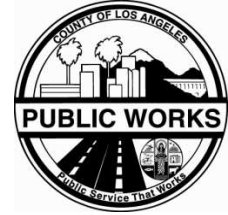




## VINE PLANTING ON HACIENDA BOULEVARD

The County of Los Angeles Department of Public Works is pleased to present plans for an upcoming vine planting project in the unincorporated County area of Hacienda Heights. The presentation will be made during the Hacienda Heights Incorporated Association meeting on November 17, 2014. Please see map on back of flyer for the project limits.

The proposed project consists of planting vine varieties: Violet Trumpet, Carolina Jessamine, and Blood-Red Trumpet. These vines are evergreen and will have purple, yellow, or red color flowers throughout the year. To support the vines, a black metal trellis will be installed in front and along the existing block walls on both sides of the street. The project also includes minor sidewalk repair and removal of trees that have damaged the sidewalk. These trees will be replaced wherever feasible.

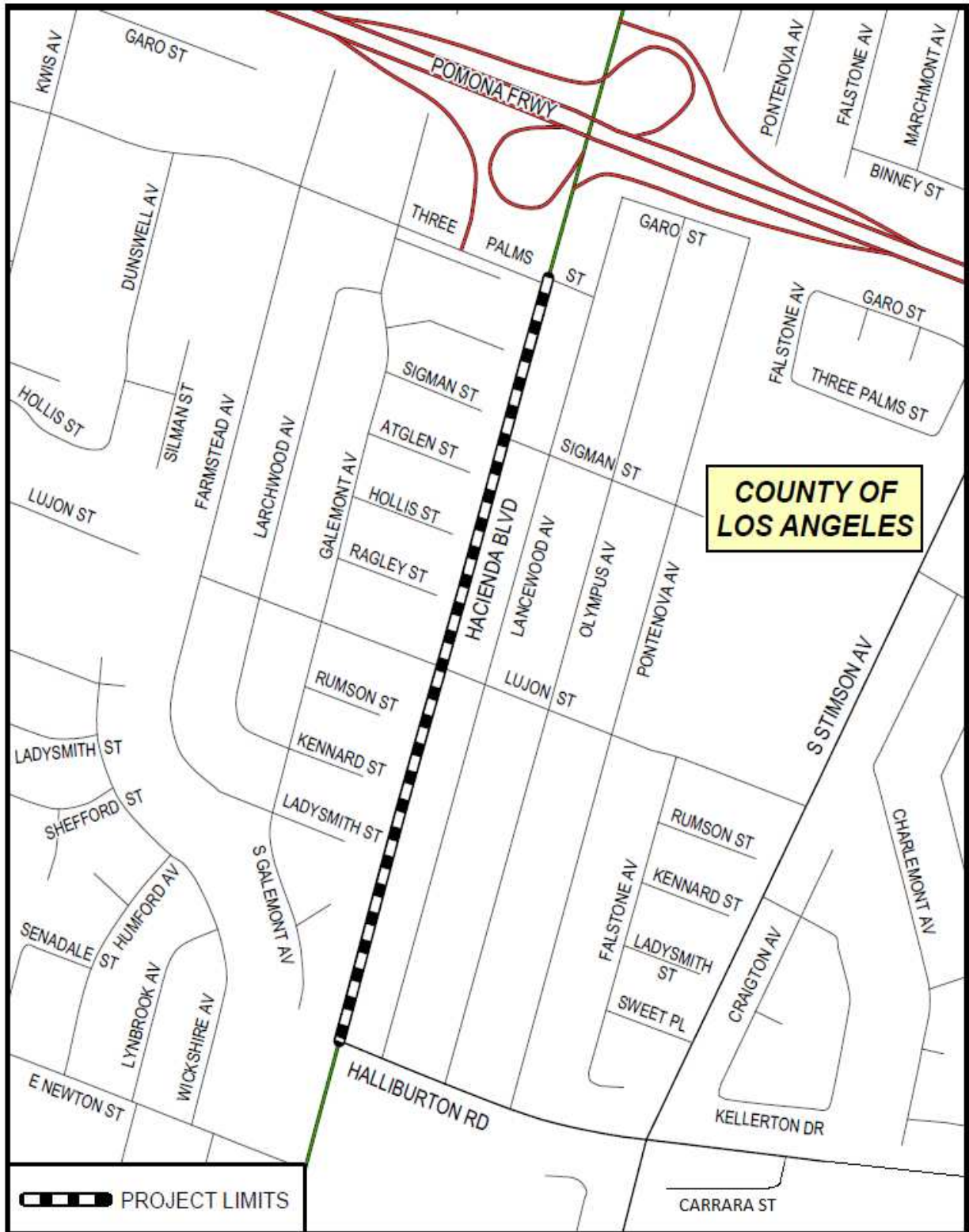
