7. Owner's Consent

I hereby certify under penalty of perjury that I have read the information below and that:

1. I am the property owner and consent to the submittal of this application and contents therein; and
2. I understand the County may revoke the temporary outdoor dining Special Events Permit (SEP), without hearing, at any time, in the County's sole discretion, for any reason including, without limitation, non-compliance, unsafe conditions, or discontinuation of the program; and
3. I understand the restaurant shall maintain a valid County of Los Angeles business license; and
4. Any live entertainment or amplified sound or music is prohibited in the temporary outdoor dining area; and
5. Food preparation is prohibited in the temporary outdoor dining area; and
6. The temporary outdoor dining area shall remain free from any food or beverage spillage or trash; and
7. I understand the consumption of alcoholic beverages within the temporary outdoor dining area can only occur if the existing establishment is authorized to sell alcoholic beverages by a valid Conditional Use Permit, is "deemed approved" pursuant to Los Angeles County Code Section 22.140.030 (Alcoholic Beverage Sales), or as otherwise approved by the SEP, and state ABC approval is first obtained. Consumption of alcoholic beverages must occur in compliance with all the requirements of the underlying approval, including hours of operation; and

I understand and agree to defend, indemnify, and hold harmless the County of Los Angeles, its Supervisors, employees, and agents in regard to any claims, lawsuits, or liability arising from injuries and/or damage caused by, or related to, applicant's or its employees or agents' conduct, including, without limitation, negligent or tortious conduct, under this SEP and/or in breach or violation of this SEP, which conduct may include, without limitation, placement, use, or maintenance of outdoor dining furnishings and equipment.
