

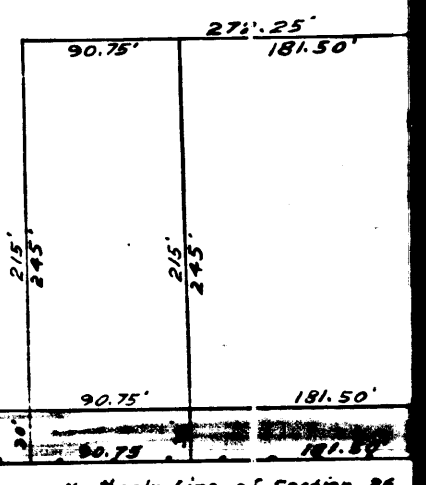

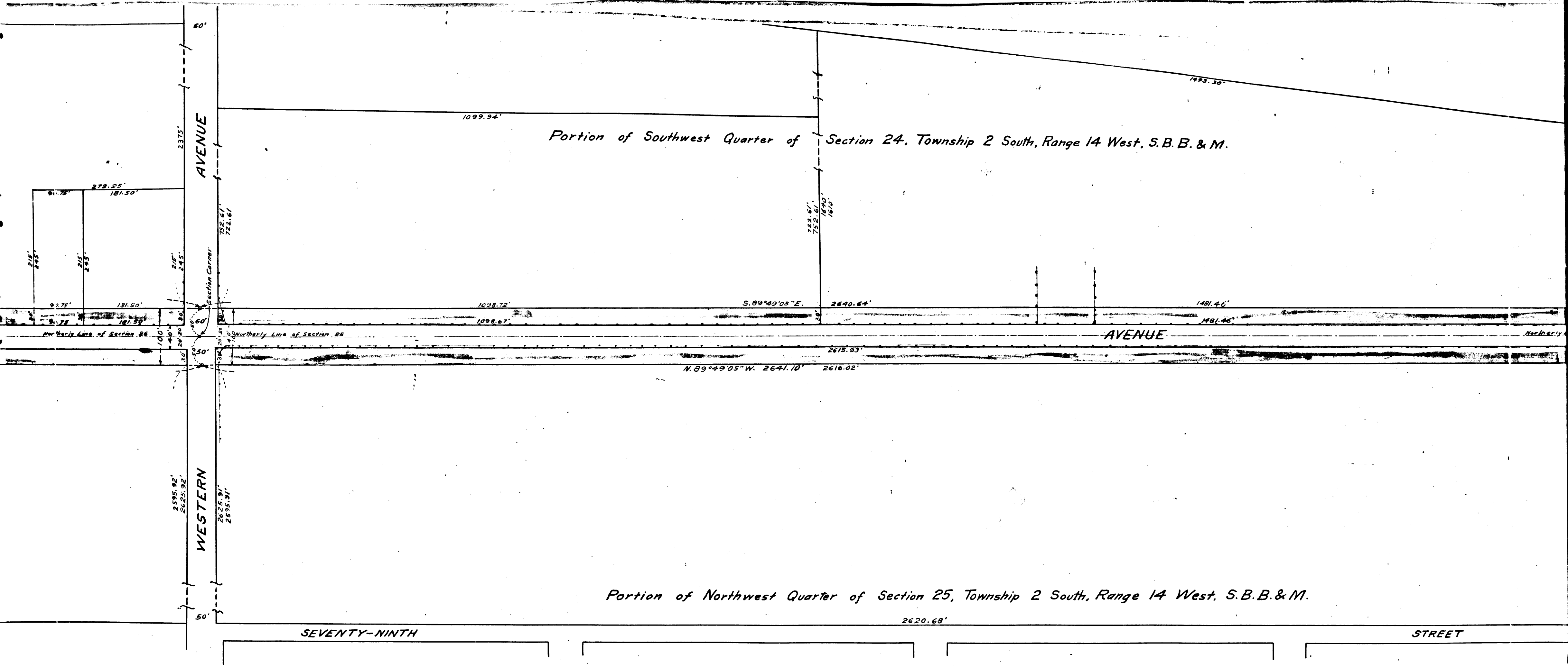
Portion of Southeast Quarter of Section 23, Township 2 South, Range 14 West, S.B.B. & M.

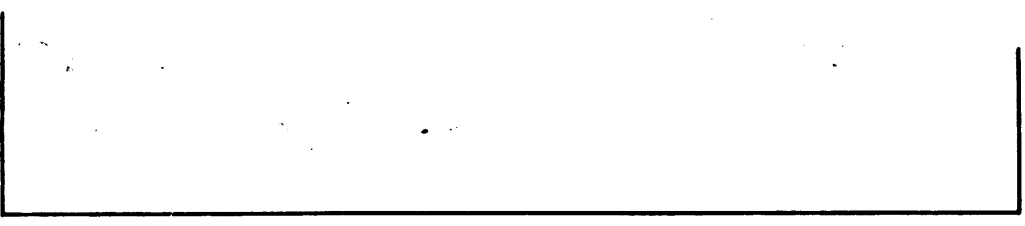


Portion of Southwest Quarter of Section 24, Township 2 South, Range 14 West, S.B.B. & M.
