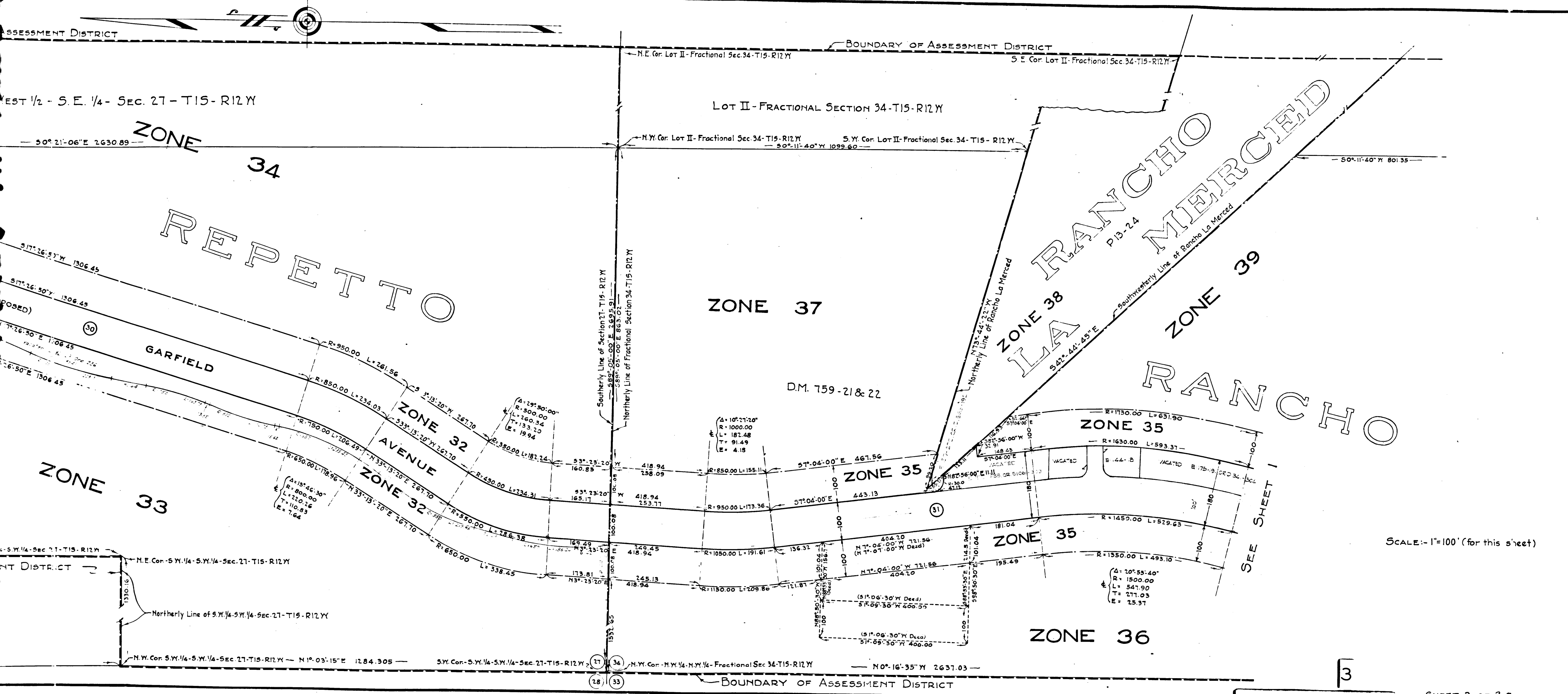

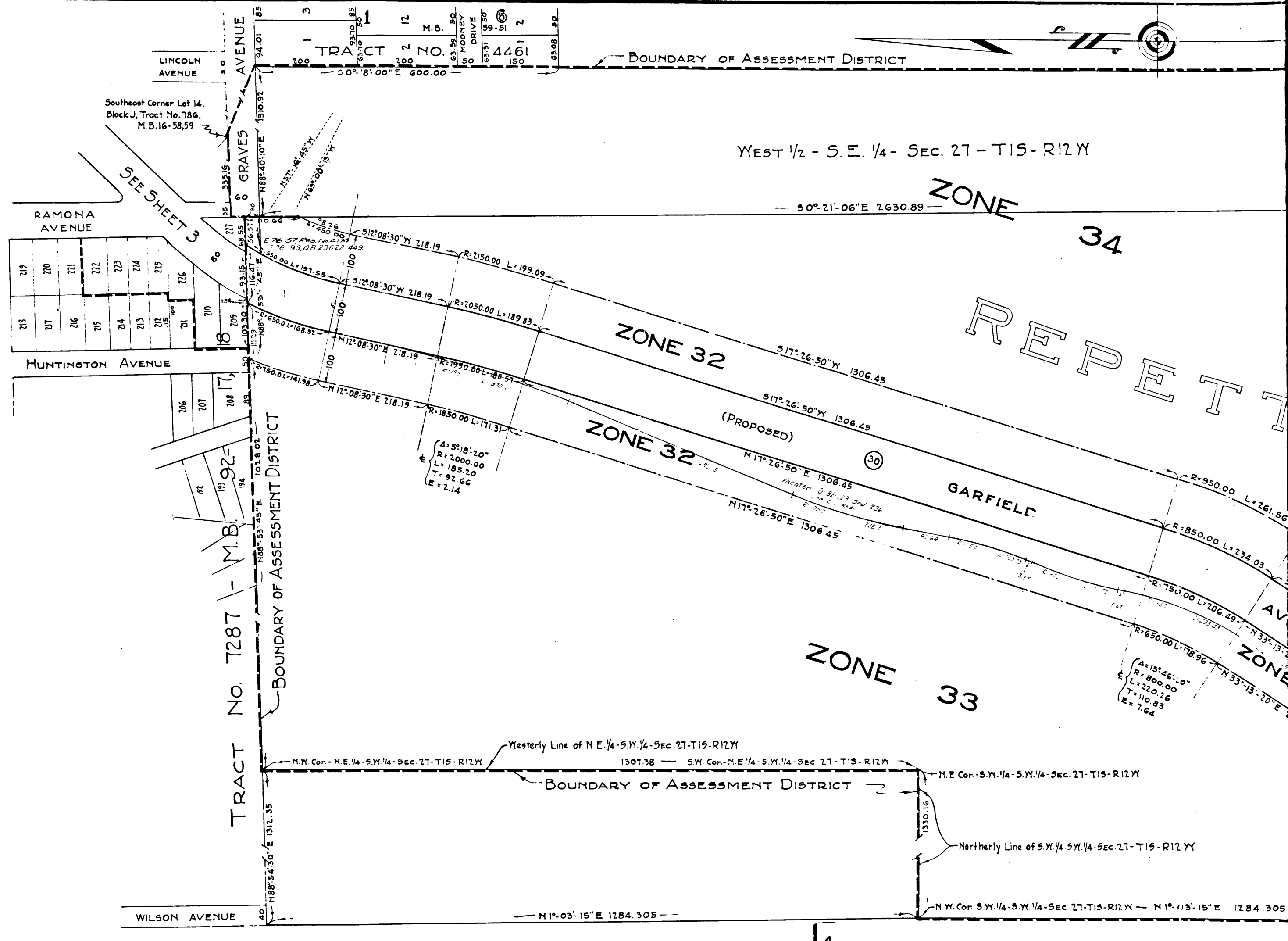


N.Y. Cor. Lot 1 - Block 1 -  
Tract No. 4461 - M.B. 59-51

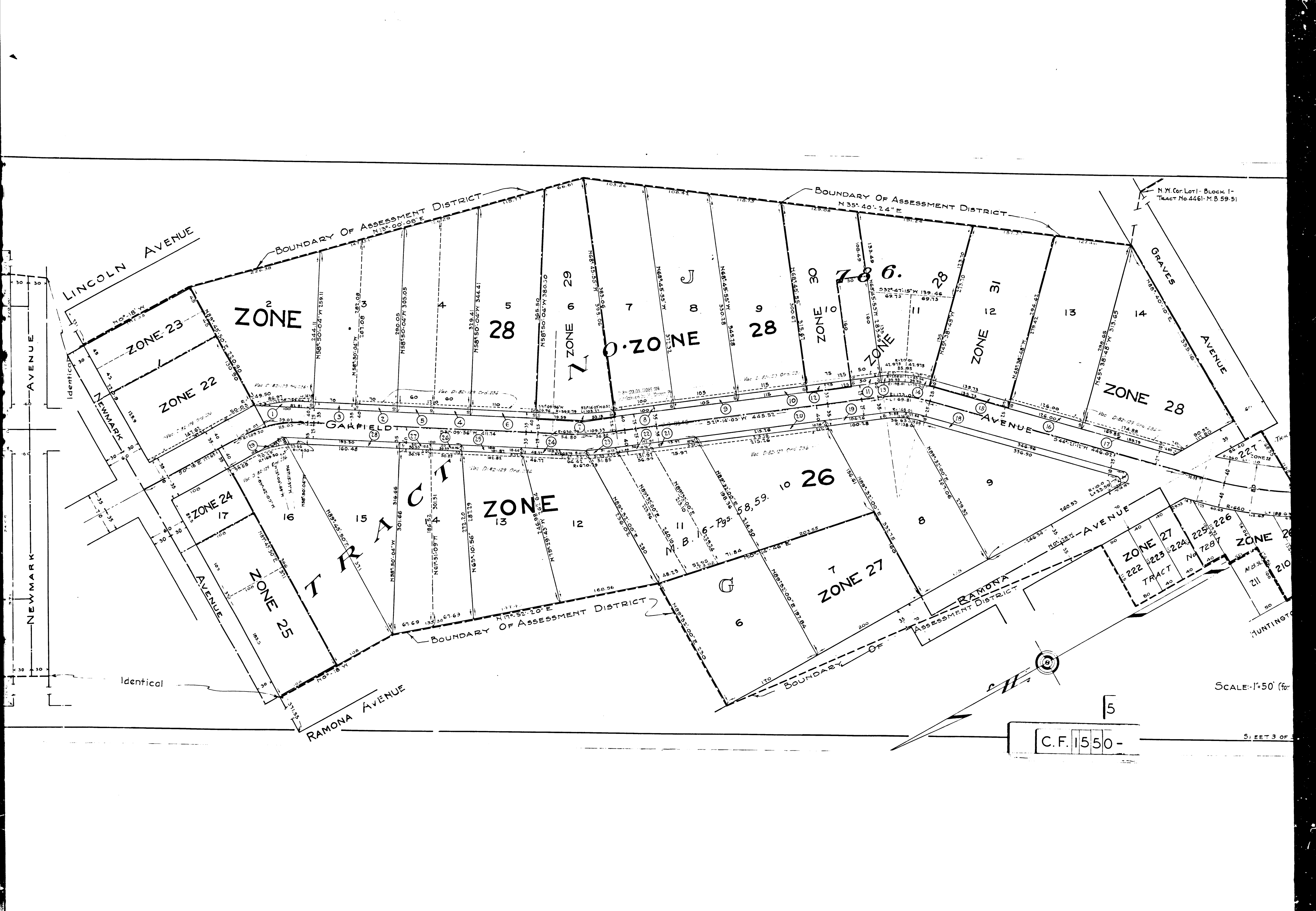

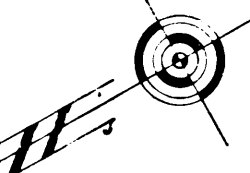
