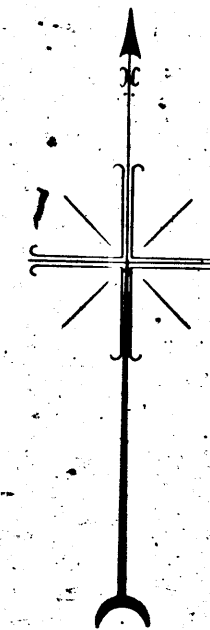


MAP

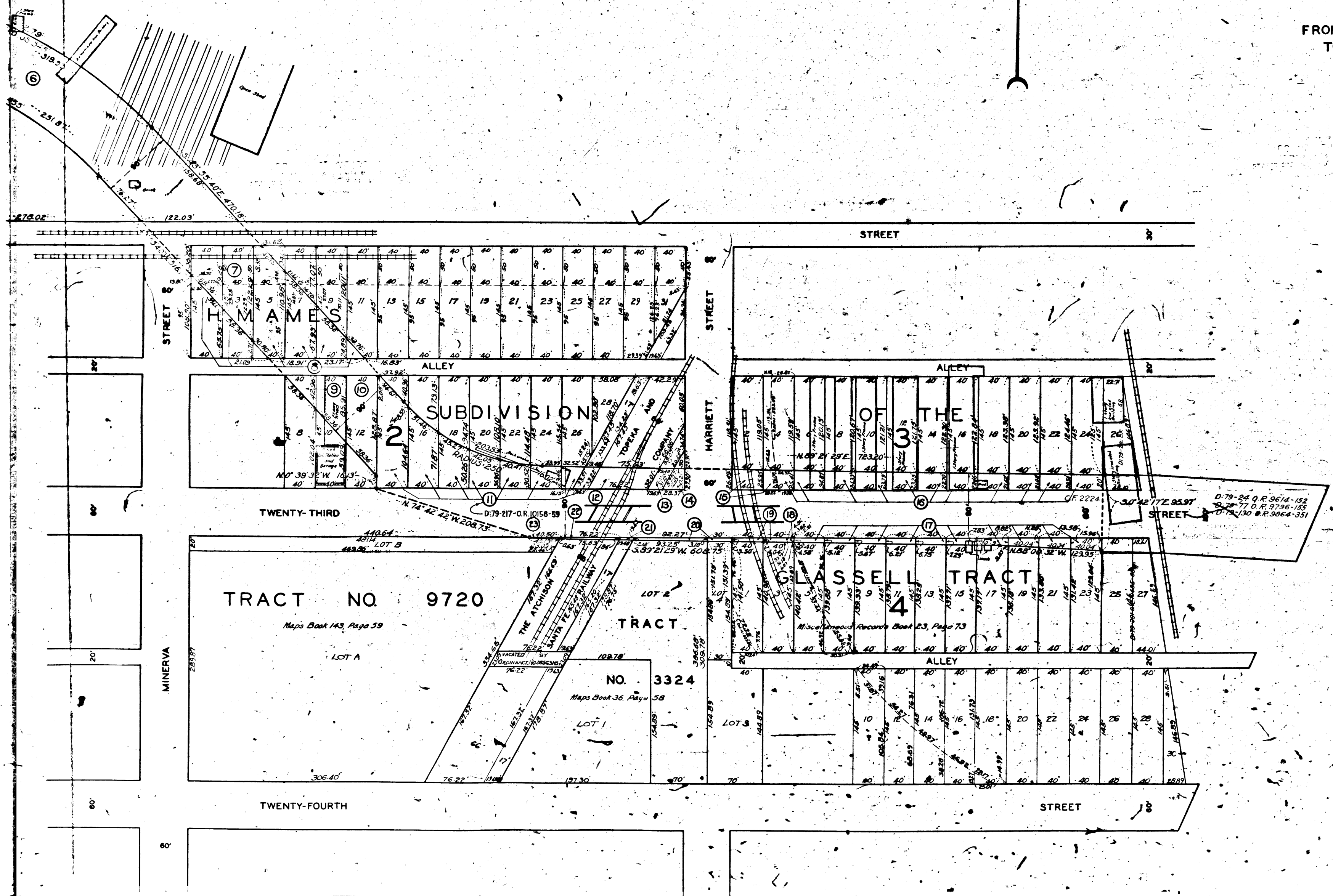
