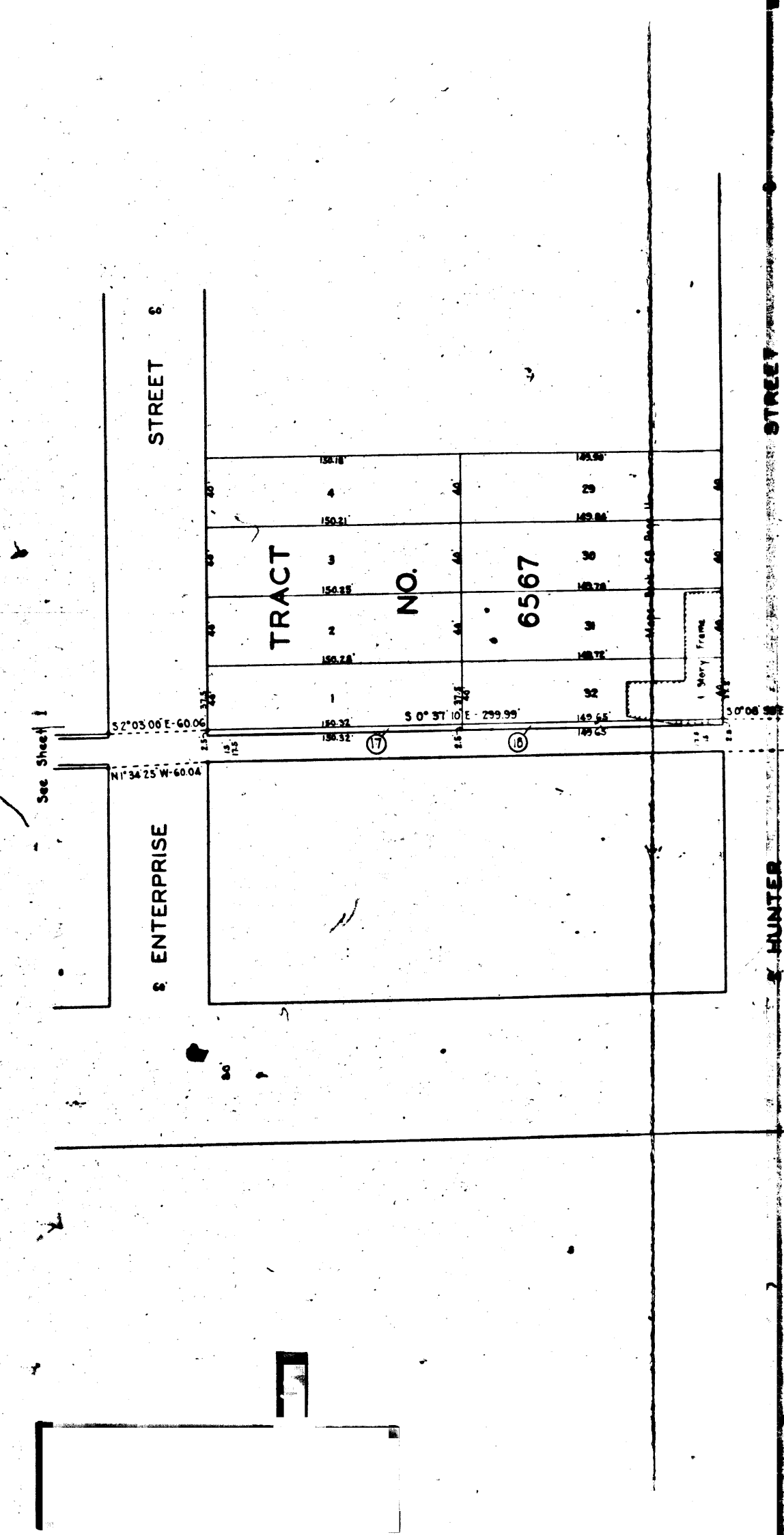
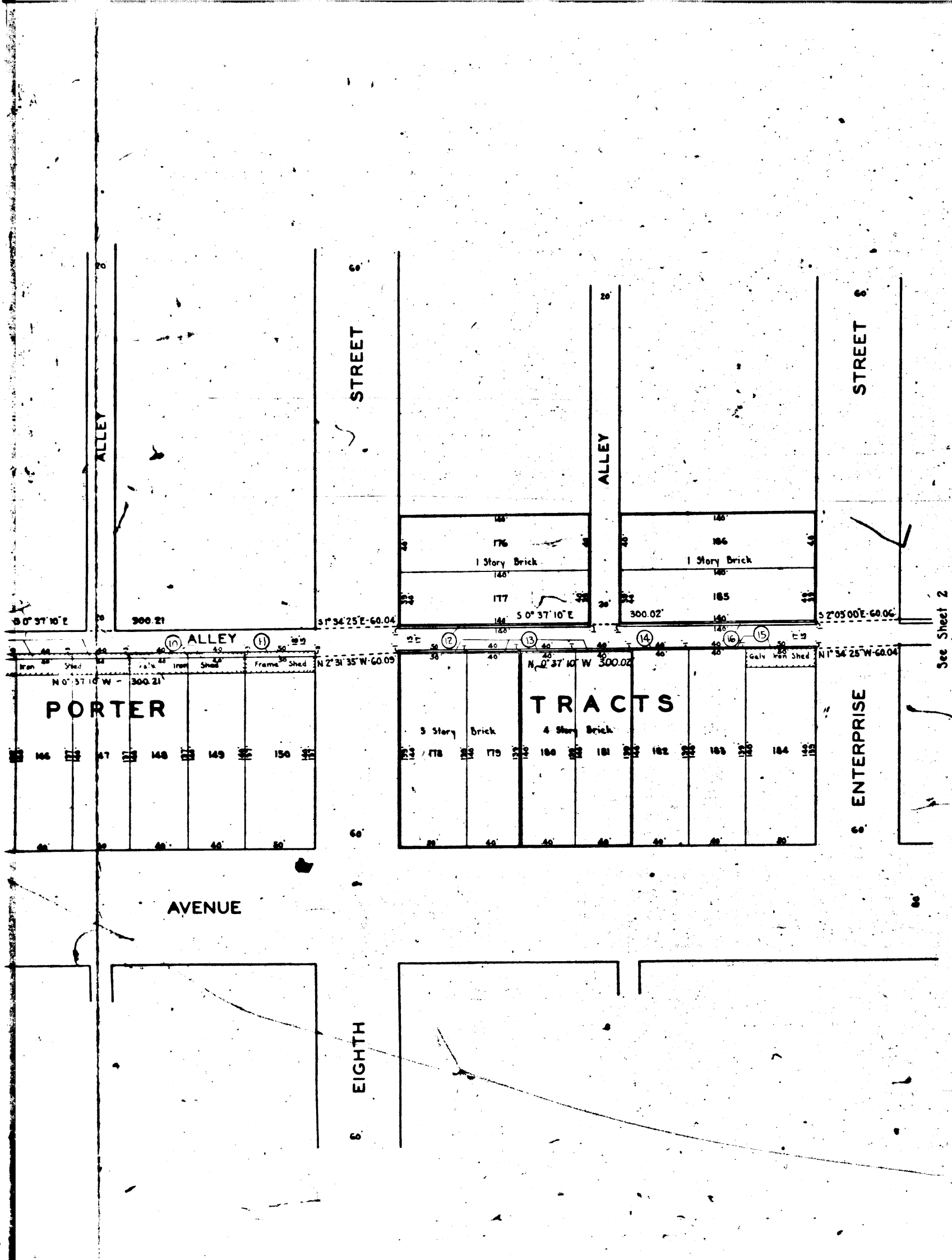
NOTES:

cases where they differ from the recorded subdivisions.

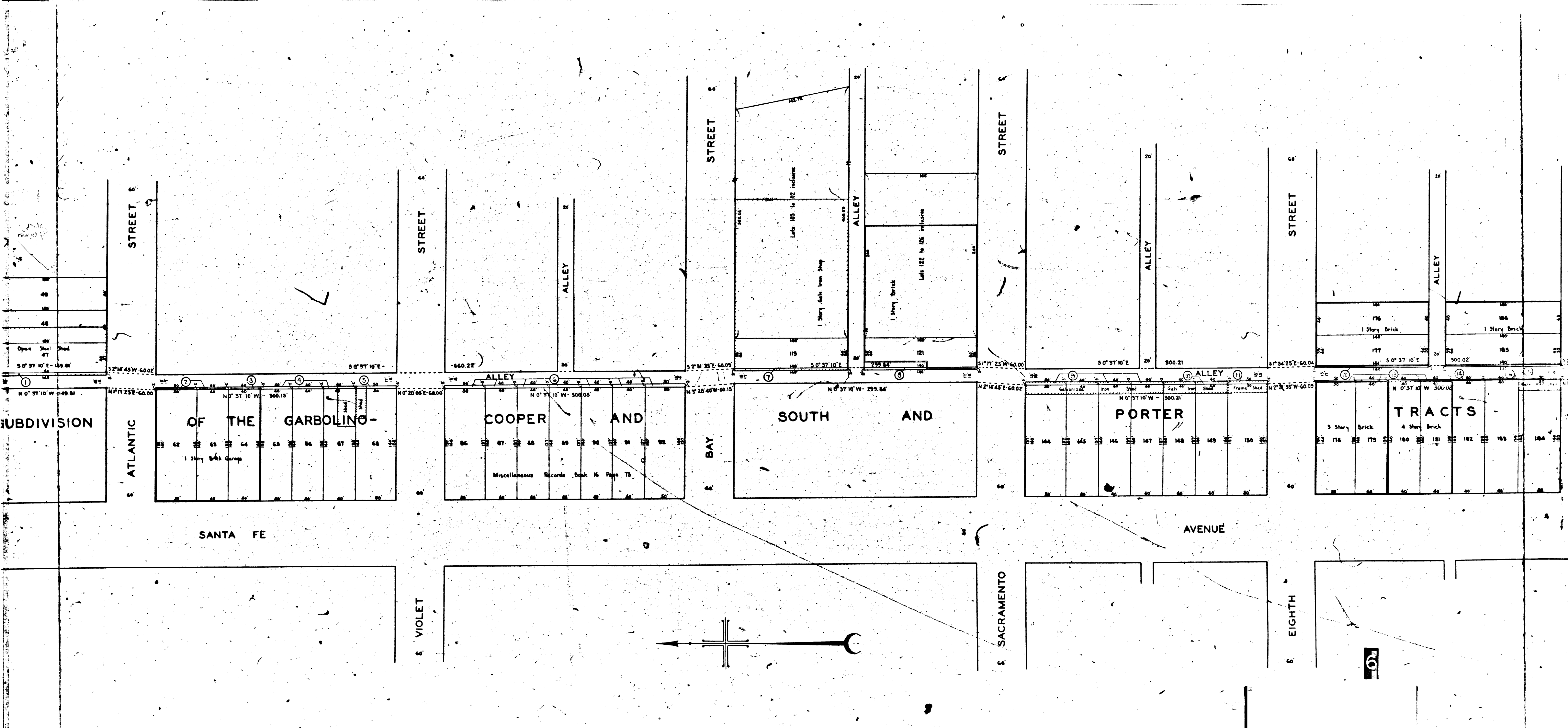

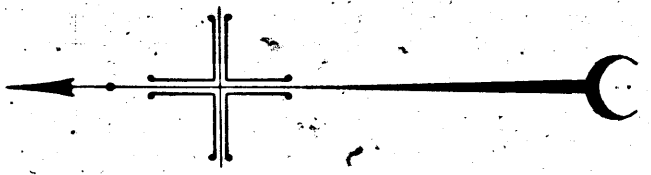

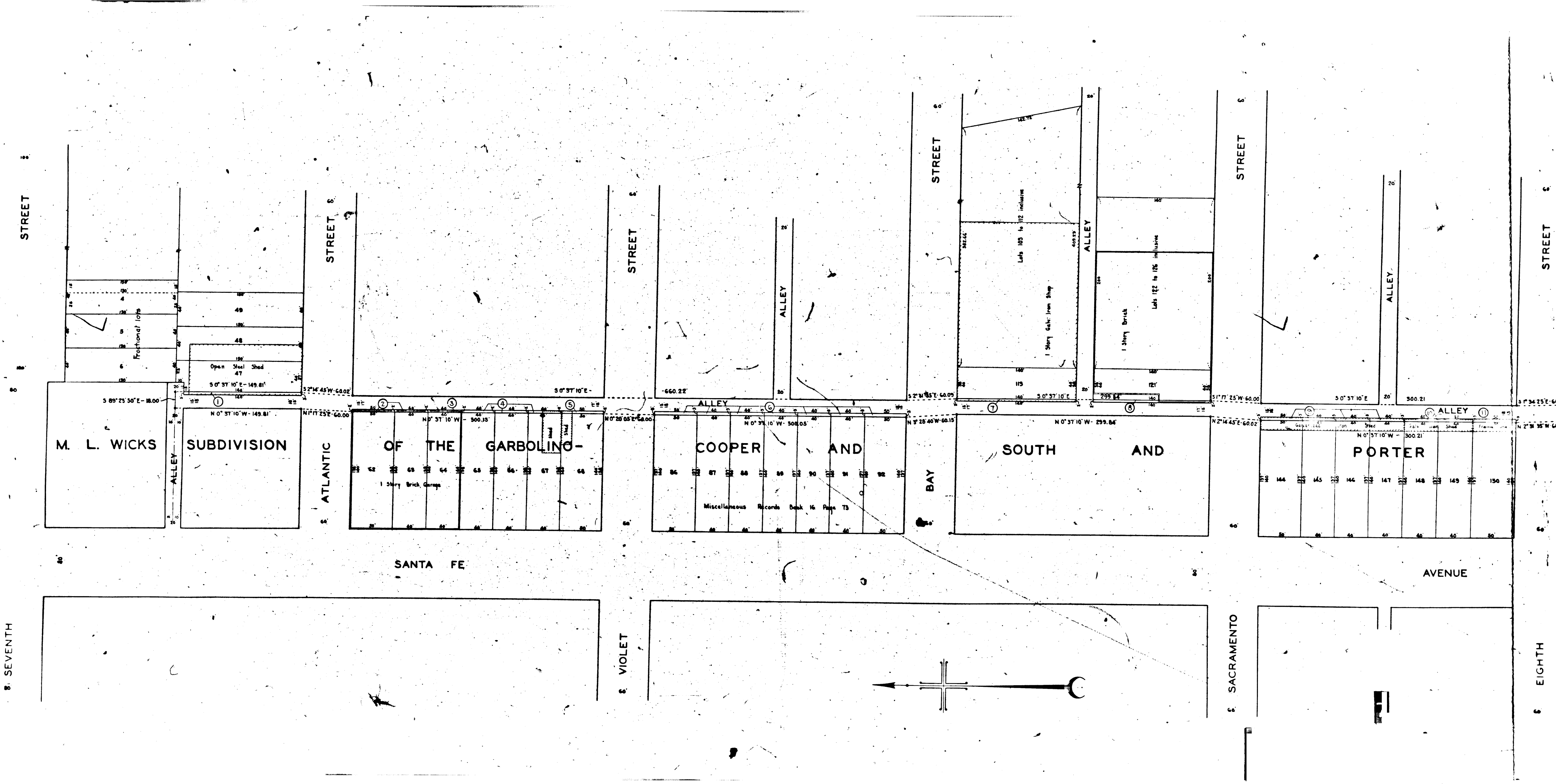
