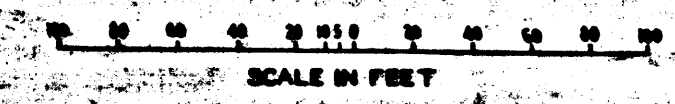


MAP

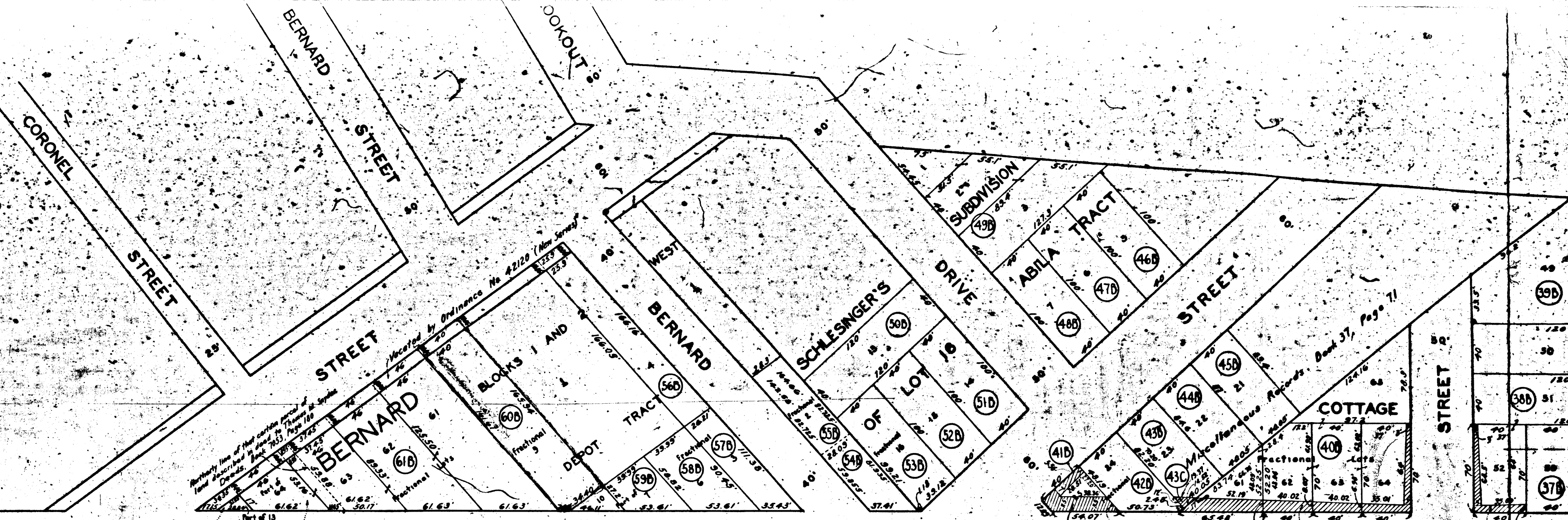

DOTTED LINES AND FIGURES SHOW PROPERTY HOLDINGS IN THOSE CASES WHERE THEY DIFFER FROM RECORDED SUBDIVISIONS. FIGURES AND LETTERS IN CIRCLES INDICATE THE PARCEL NUMBERS AS SET FORTH IN PARAGRAPH II OF THE COMPLAINT.
