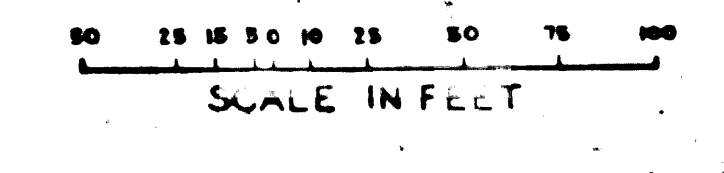




# MAP

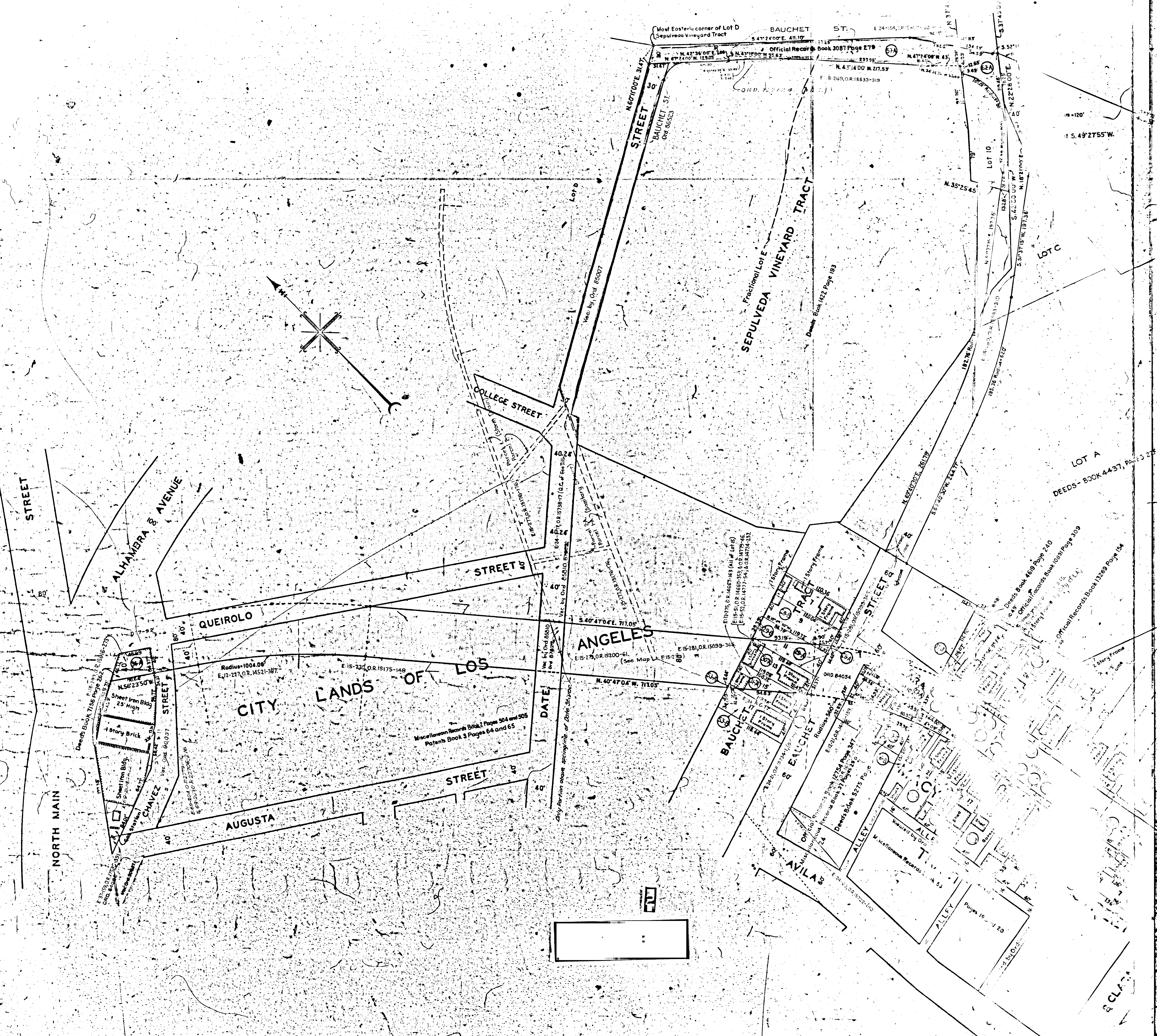
