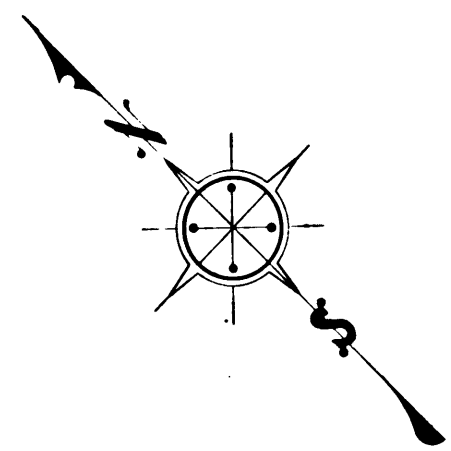

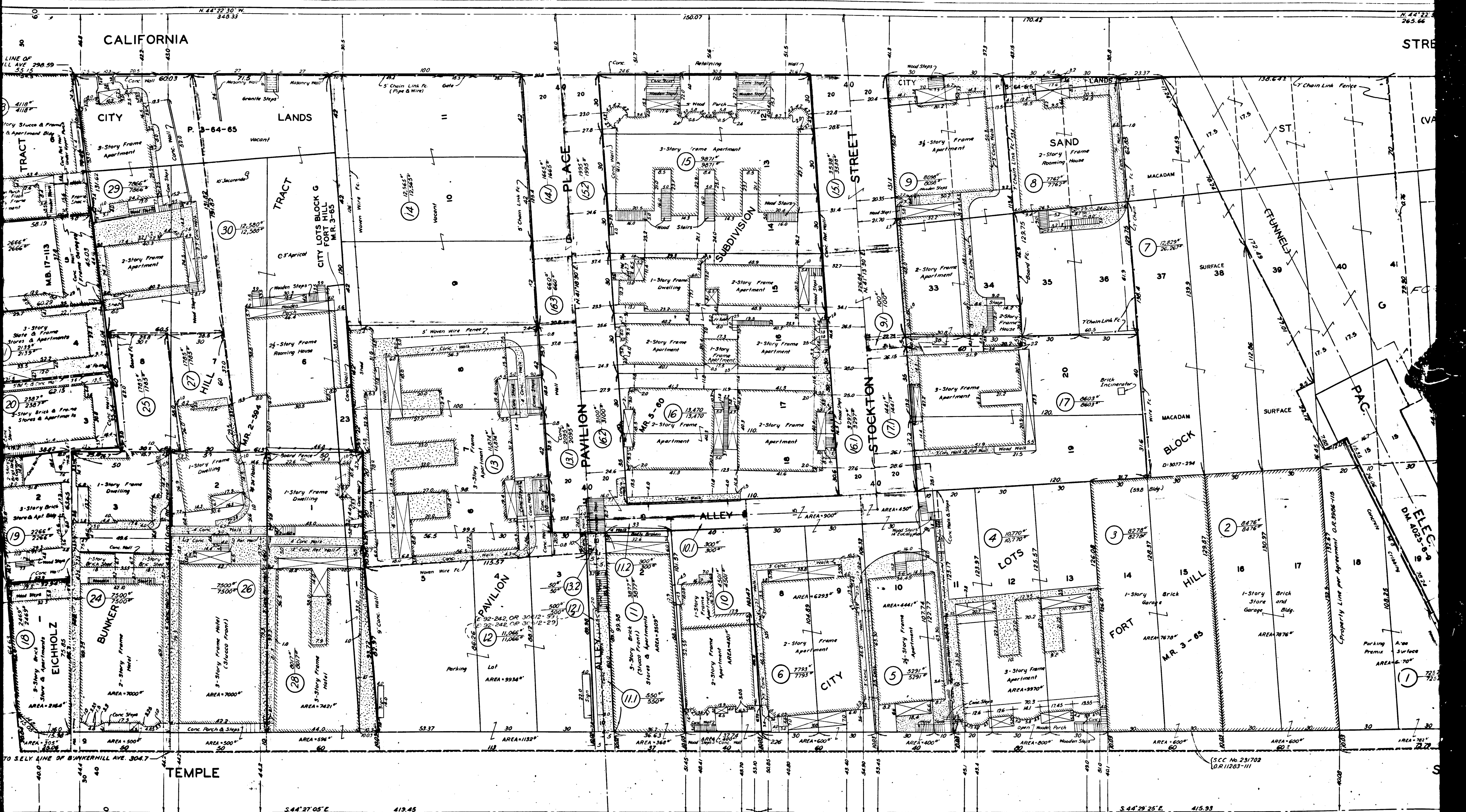

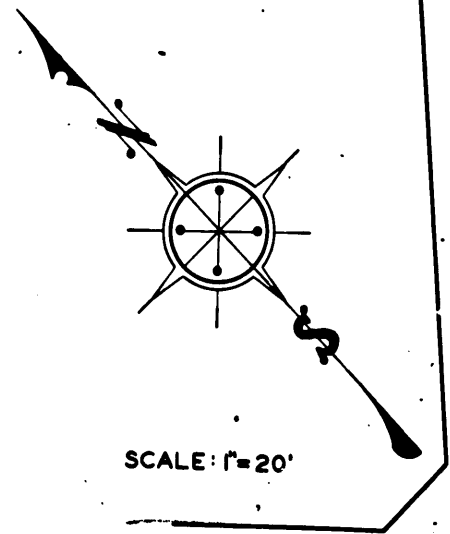
INDEX MAP 2 (C-3 & 4) ASSESSOR BOOK 19
