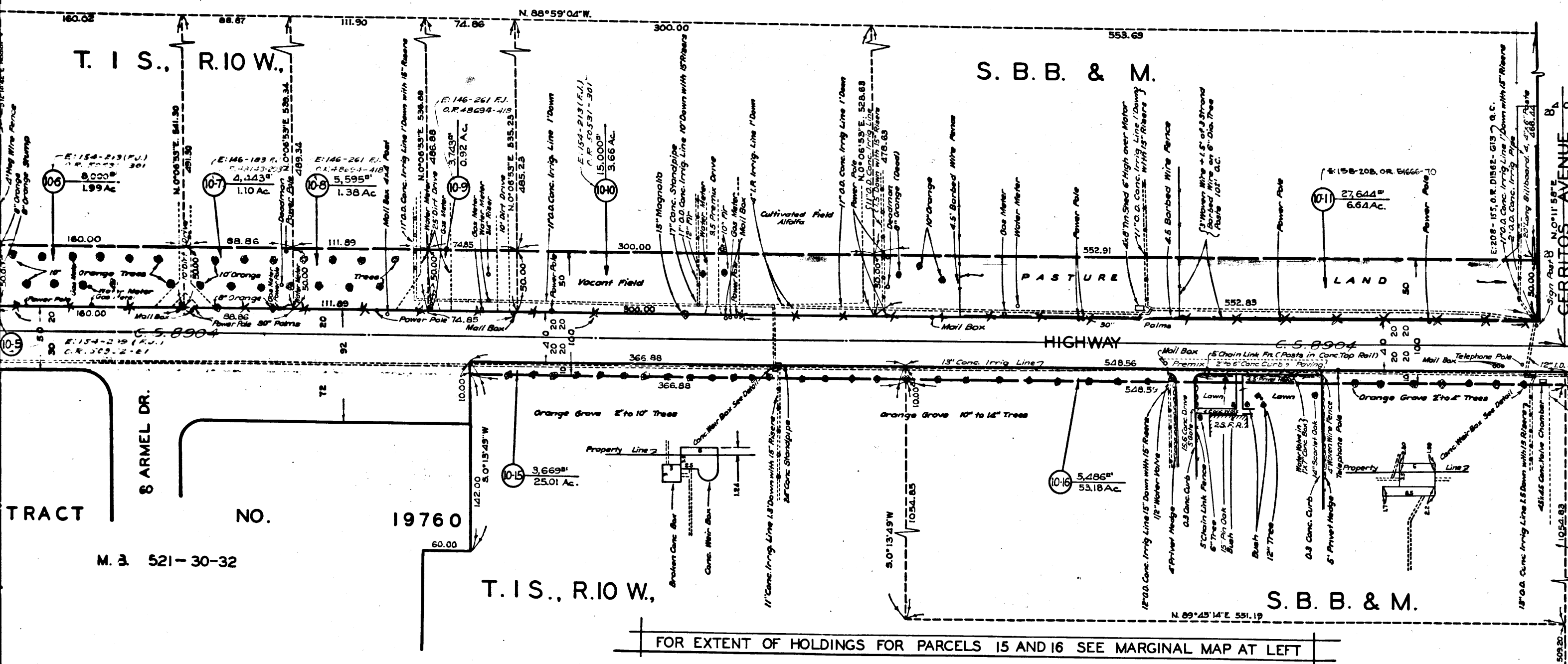

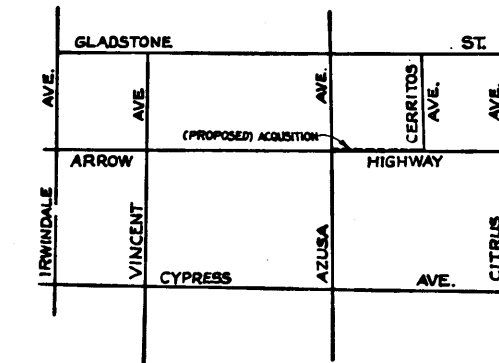

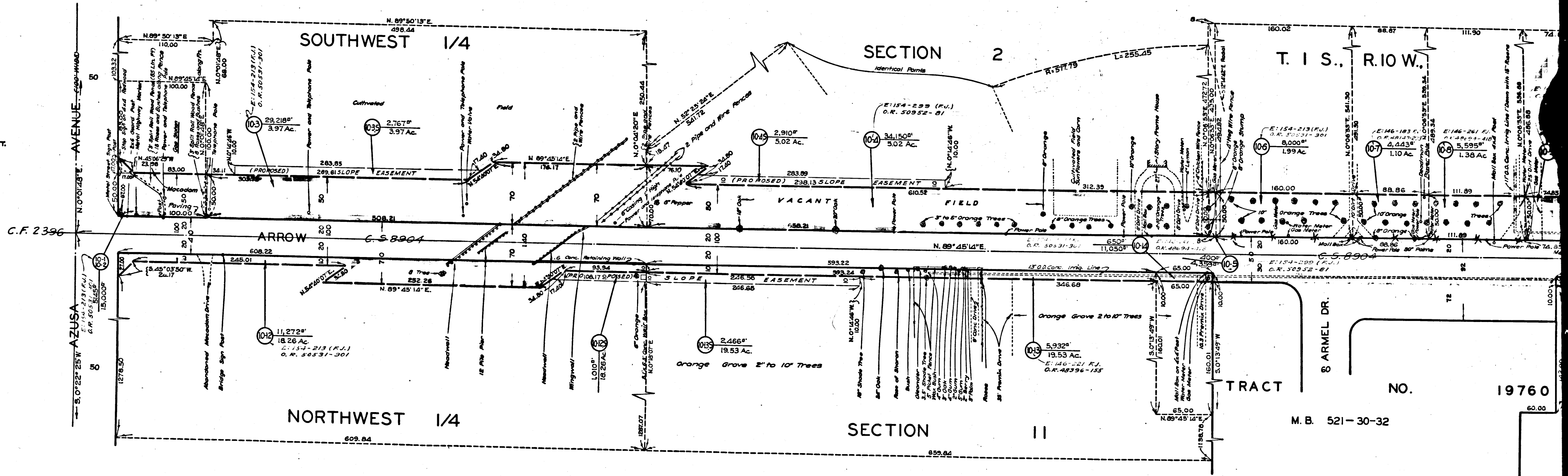
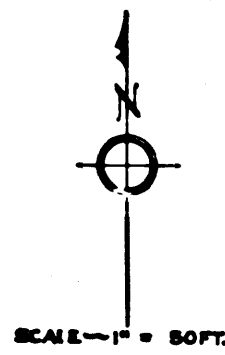


VICINITY MAP.
 NOT TO SCALE



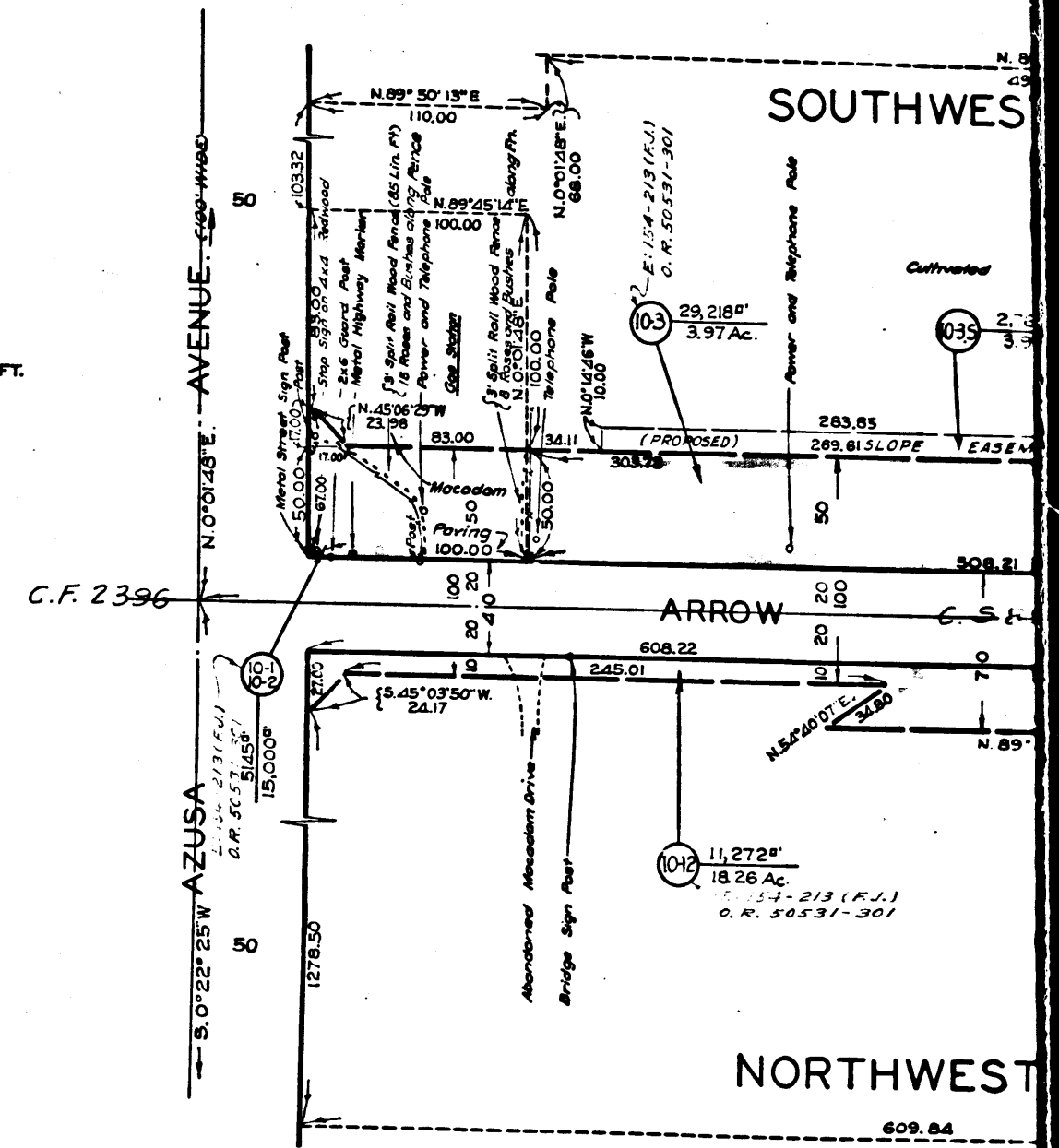
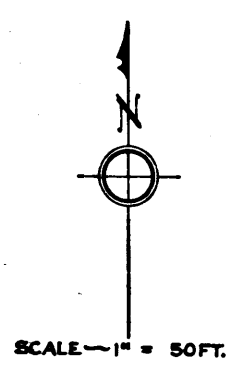
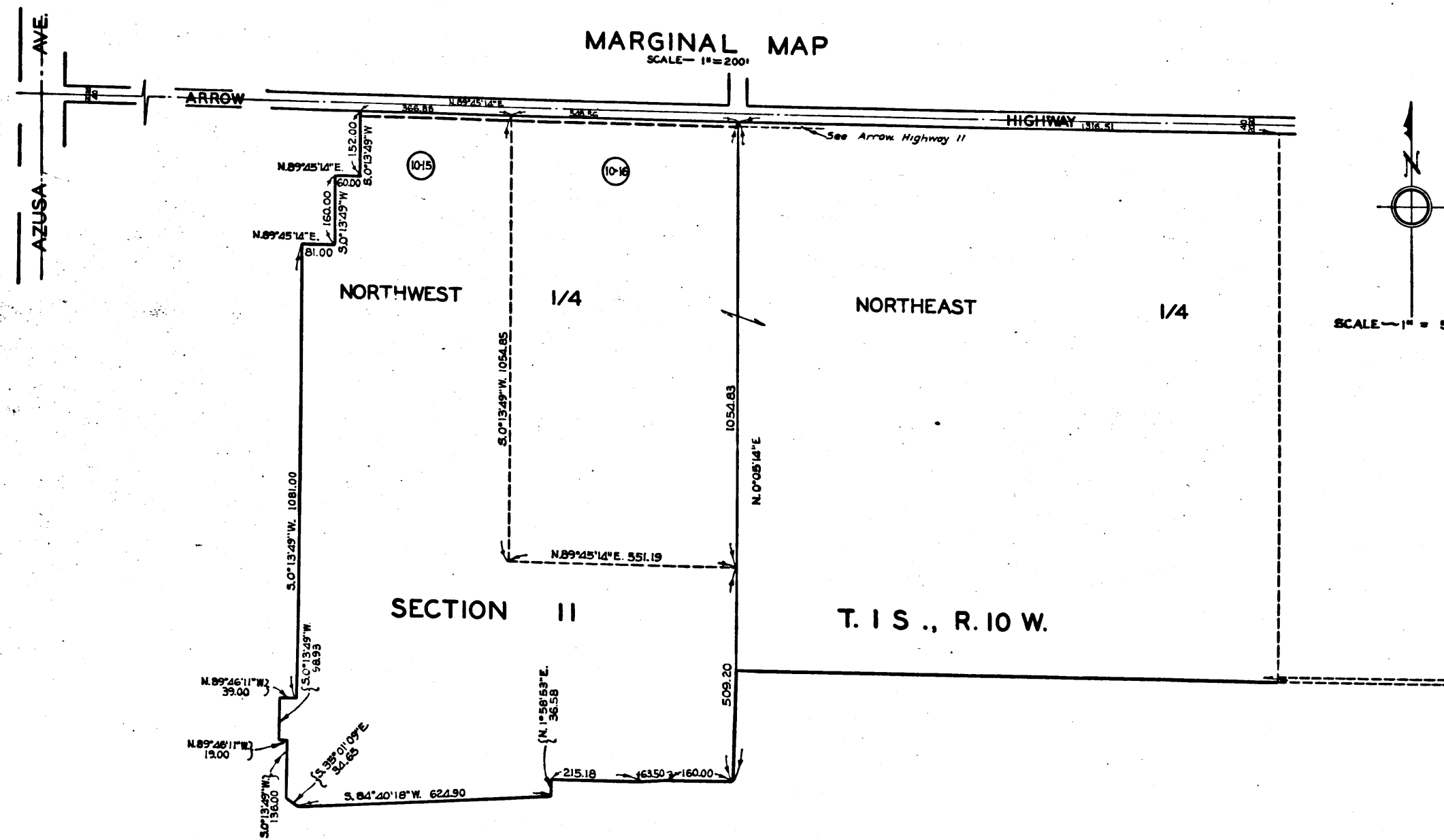
