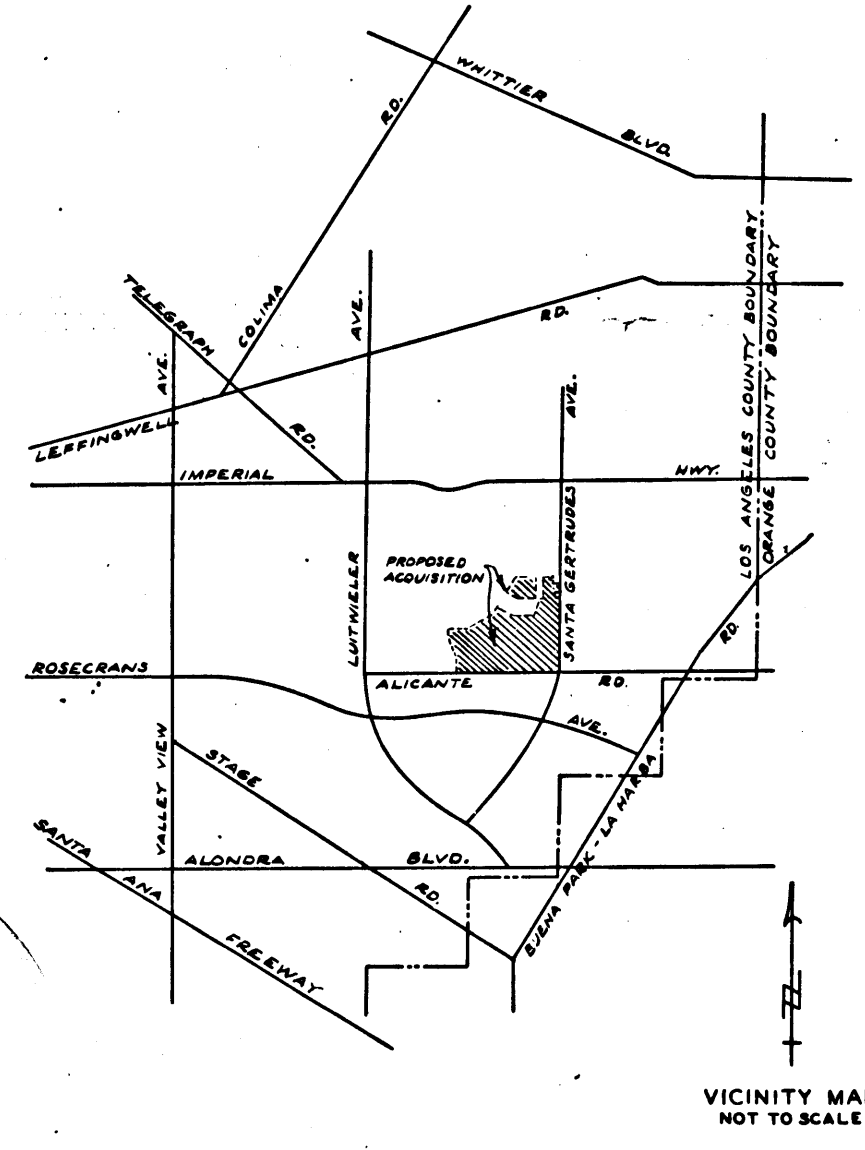

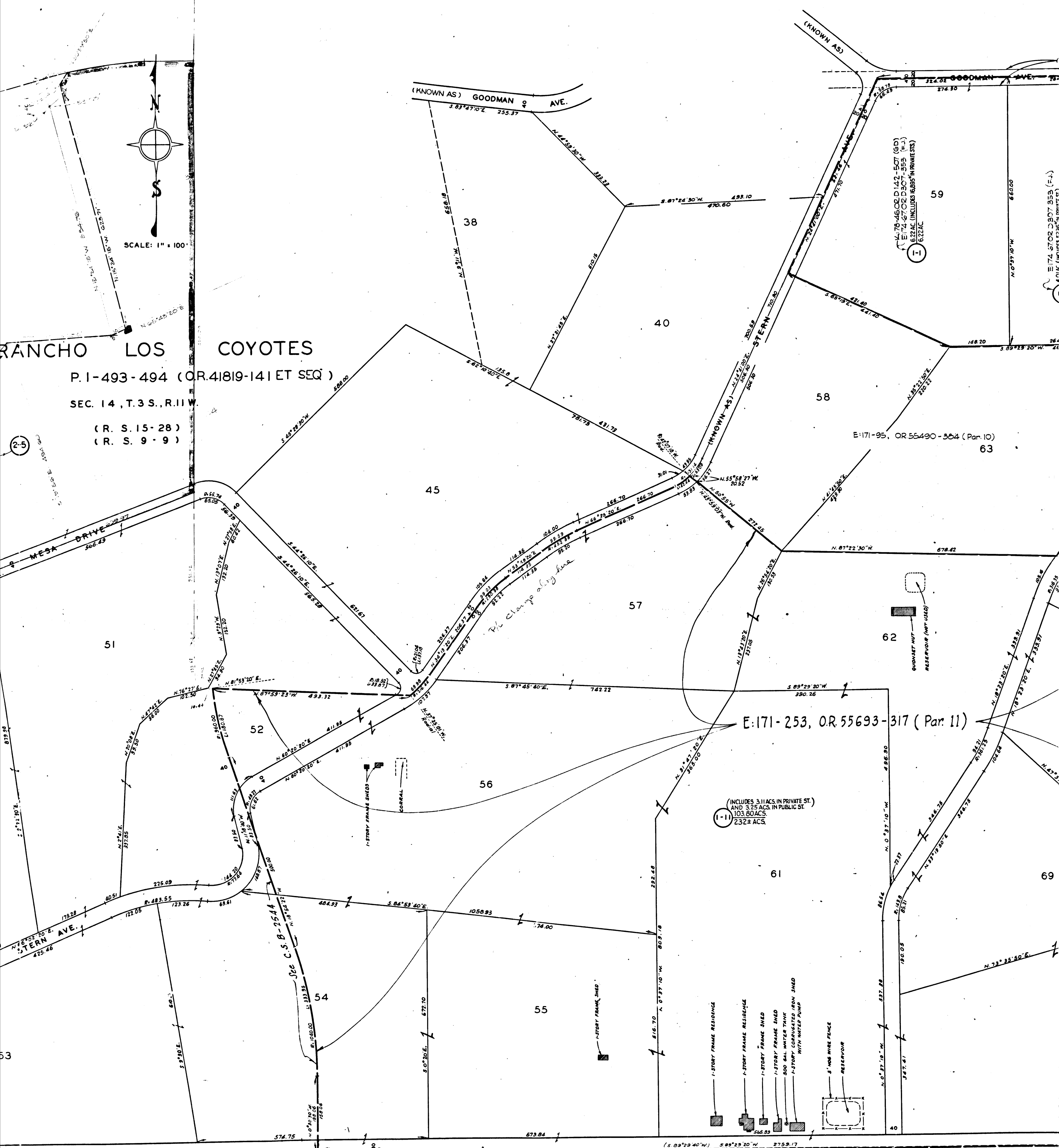

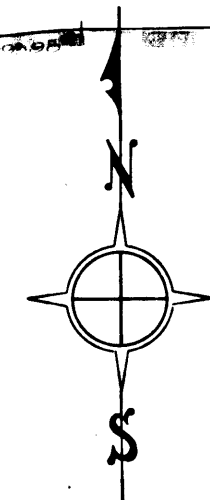
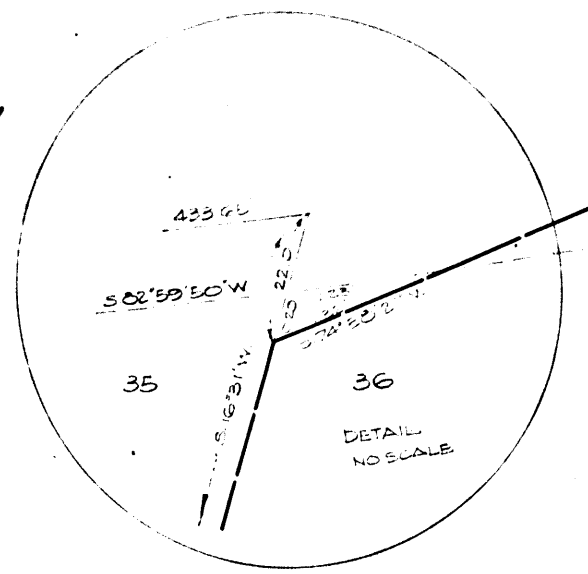


SOUTH 1/4 CORNER SECTION 14, T.3 S., R.11 W.

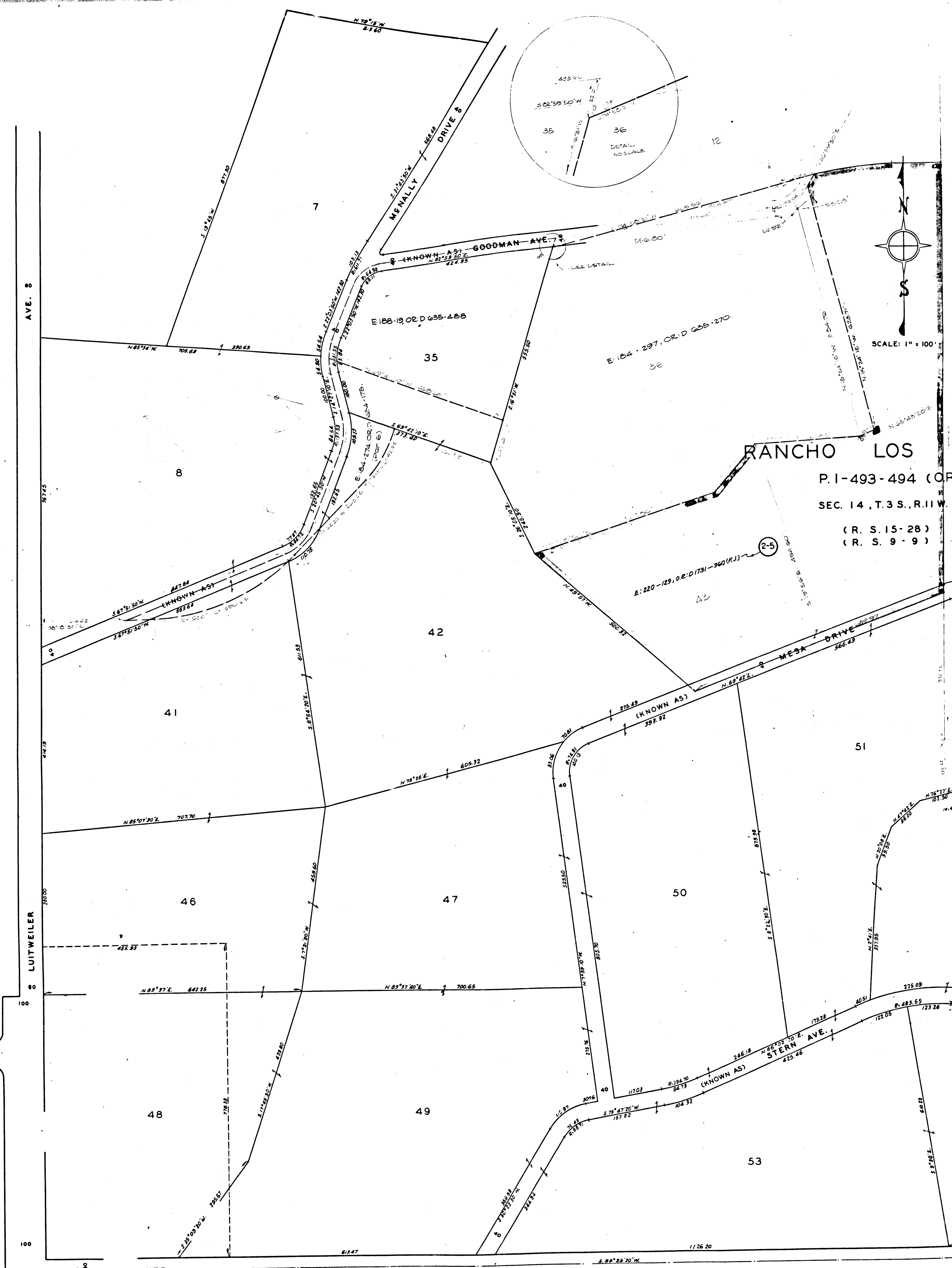
