This was declared to be a Public Highway by order of the Board of Supervisors on August 5th 1901, as shown in Road Book 6 page 330; the courses and distances being shown on County Surveyors Map No 3560; and a portion of which was deeded to Los Angeles County for road purposes as recorded in Deed Book 2313, page 158, Records of Los Angeles County, Cal. and shown on County Surveyors Map No 7170.
