5.00 To base of spur of the mountain range on S. & W.  
 11.00 To east slope of spur, and finding that from this point, West on line there is nothing to be met with save an indefinite or interminable series of twisted ridges, chopped by innumerable gulches with nearly perpendicular faces, and consequently too rough to measure with accuracy, we set post in an irregular mound of rock and return to cor. of secs. 33, 34, 3 & 4 from which we run north on offset by Sec. lines.

40.00 North between Secs 33 & 34.  
 Set **gr.** Sec. post and charred stake in mound with trench and pits as per instructions.

67.50 Across broad ravine 20 chs. wide, and dry arroyo 60 lks wide. course N.E.

75.00 Across wagon road agrin. course N.W.

80.00 Set sec. post and charred stake in mound, with trench and pit as per instructions, cor. secs. 27, 28, 33 & 34. Some 30 chs S.E. of the N.W. terminus of a high range of hills commencing at the river where the south boundary of Township 5 N. r. 9, crosses it.  
 Undulating Land. Soil 3rd rate. Thence

11.50 West on south boundary of sec. 28.  
 Across road again, course N. W.

15.50 Across dry bed of Arroyo, 60 lks. wide, course N. W.

40.00 Set **gr.** sec. post and charred stake in mound with trench and pits as per instructions.

80.00 Set sec. post and charred stake in mound with trench and pit as per instructions. Cor of Secs. 28, 29, 32 & 33, within some 25 chains of mountains on the south, and about 50 chs. of mountains on the West. Undulating land. Soil of first 60 chs. second rate, last 20 chs. third rate.

42.50 Across dry Arroyo 15 lks. wide, course West, banks 5 feet high,  
 80.00 Drive Sec. post and charred stake, and dig trenches as per instructions, cor. of secs. 20, 21, 28 & 29, from which a Spanish Bayonet 7 in. diam. N. 36. W. dist. 51 links. A Spanish Bayonet 11 in. diam bears S. 32 W. dist. 120 links. Undulating land, sloping north. Soil second rate.

80.00 Drive sec. post and charred stake and dig trenches as per instructions, cor. of secs. 19, 20, 29 & 30, from which a Spanish Bayonet 8 in. diam. bears N. 76 E. dist. 67 lks. a Spanish Bayonet 8 in. diam. bears S. 75 1/4 E. dist. 96 lks. Rolling land, sloping N. and within some 30 or 40 chs. of base of Mountain on the South. Soil second & third rate.

5.00 West on south boundary of Sec 19.  
Across dry Arroyo, 25 lks. wide, course N.E.

19.50 Across another dry Arroyo 80 lks wide, course N.

40.00 Set gr. sec. post and charred stake in mound with trench and pit as per instructions, on N. base of foot hills with Cedar timber.

61.50 To E. bluff of Ravine.

64.00 Center of same, course N. E.

72.00 To top of W. bluff of same. *13*

77.50 Set Sec post and charred stake in mound with trench and pits as per instructions on W. boundary cor. of Secs 19, 24, 25 & 30, allowing the calculated convergency of R. 10 W. 247 lks. First half mile rolling land; last broken, Soil third rate.

80.00 Drive Sec. post and charred stake and dig trench as per instructions, cor of Sec. 13, 18, 19 & 24, from which a Spanish Bayonet 10 in. dia. bears N. 7 W., dist. 68 lks. a Spanish Bayonet 11 in. diam. bears N. 33 E. dist, omitted through error. First half mile hilly, last N. base of the mountain sloping N. Mostly third rate soil.
