GENERAL DESCRIPTION.

Section 10 embraces three conical and rocky hills, the larges of which is situated in the N. E. qr. Sec. and is nearly a mile in circumference at its base. Height 150 feet. The tops of these hills range S. W. & N. E., the third and smallest being in the S. W. cor of the Sections. The Northern half of Sec. 4 falls on the Southern slope of a Mountain. The remaining portion of the Township is principally level land, but gently sloping North. In the Southern Sections there are a few scattering Cedar. The Spanish Bayonet and Heronia are found throughout the Township. The pasture of bunhh grass and Chimise is generally good. The soil seems well adapted to the growth of Wheat and small grain.
