

GENERAL DESCRIPTION.

This fractional Township consists principally of undulating hills well adapted to grazing, the principal part of which has resulted from excess from the Rancho "Rincon de la Brea", and the remainder from that of the "Los Bogales".

REMARKS

This fractional Tp. is bounded on the East by the Rancho "Santa Ana del Chino" from & mile N.W. from the southern boundary up to & Sec. Cor. on E. boundary of Section 12.

On the South to a point 50.60 chs. W. of corner to Sections 4, 5, 32 and 33 lies public lands and from said point to corner to Sections 17, 18, 19 and 20, by the Rancho "Rincon de la Brea"; thence by the "La Puente" and "Los Mogales" to the Morthern boundary.

The S. boundary of the Rancho "San Jose" entering the N.E. portion of Sections L. for which, see field notes of same.

GENERAL DESCRIPTION

The northerly portion of this Fr. Township is very hilly, the southerly and western undulating. The former well adapted to grazing, the latter either to grazing or the growth of Wheat or other cereal crops. The timber consists principally of Sycamore and is confined to the canons.

REMARKS

By reference to and being governed by the attached decree in the matter of the Rancho of Cajon de San Juan, I retrace the East boundary of said rancho from Sta. No. 3 of Rincon de la Brea a certain live oak as fixed by said decree passes a Sycamore on the ranch line at a course S. 5to E., Var. 13°25' E. and find that it intersects the South boundary of the Township 16.85 chains west of cor. of Secs. 32 & 33.
