### Boundary Line of San Gabriel Forest Reservation.

Along N. Bdy. T. 2N. R. 14 W. S.B. M.

From the true point for \$\frac{1}{4}\$ section corner, 1.35 chains east of witness corner, I run

West on a random line between Sections 6 and 31.

46.77 To a point 3 links north of old witness corner to Townships 2 and 3 Worth, Ranges 14 and 15 West, where I found a stone mound but no other trace of corner.

September 25th, at 6b. 30m. A.M., l.m.t., I lay off the azimuth of Polaria 1°30.06' to the west and mark the true meridian thus determined by cutting a mark on a stone set firmly in the ground, west of the point established last night.

The mag. bearing is north 15°01' west, which reduced by the table on page 100 of the manual gives the mean magnetic declination 15°00' east. At 7h. 00m. A.M., l.m.t. I set off 34°24' north on the lat arc; 1°09' south on the decl. arc and determine the true meridian with the solar at the corner to townships 3 and 4 north, ranges 14 and 15 west, previously described. From the corner to townships 3 and 4 north, ranges 14 and 15 west, I run north on a random line along boundary.

I make diligent search for old corners, along line, but failing to find any trace of same, set temperary corners at every \$0.00 chains and at 230.10 chains arrive at a point 2.03 chains west of corner to Sections 13,15,19 and 24, where I found a portion of an old mound, but no other trace of corner.

To fully establish the position of this corner, I go to the quarter section corner between Sections 13 and 15, on the west boundary of township, which is a decayed stake, in an old stone mound. I destroy stake and to remark corner set a sandstone 16 x 10 x 5 inches, 11 inches in the ground, marked \(\frac{1}{4}\) on west face; and rebuilt stone mound,  $1\frac{1}{2}$  ft. high, 2 feet base west of corner.
