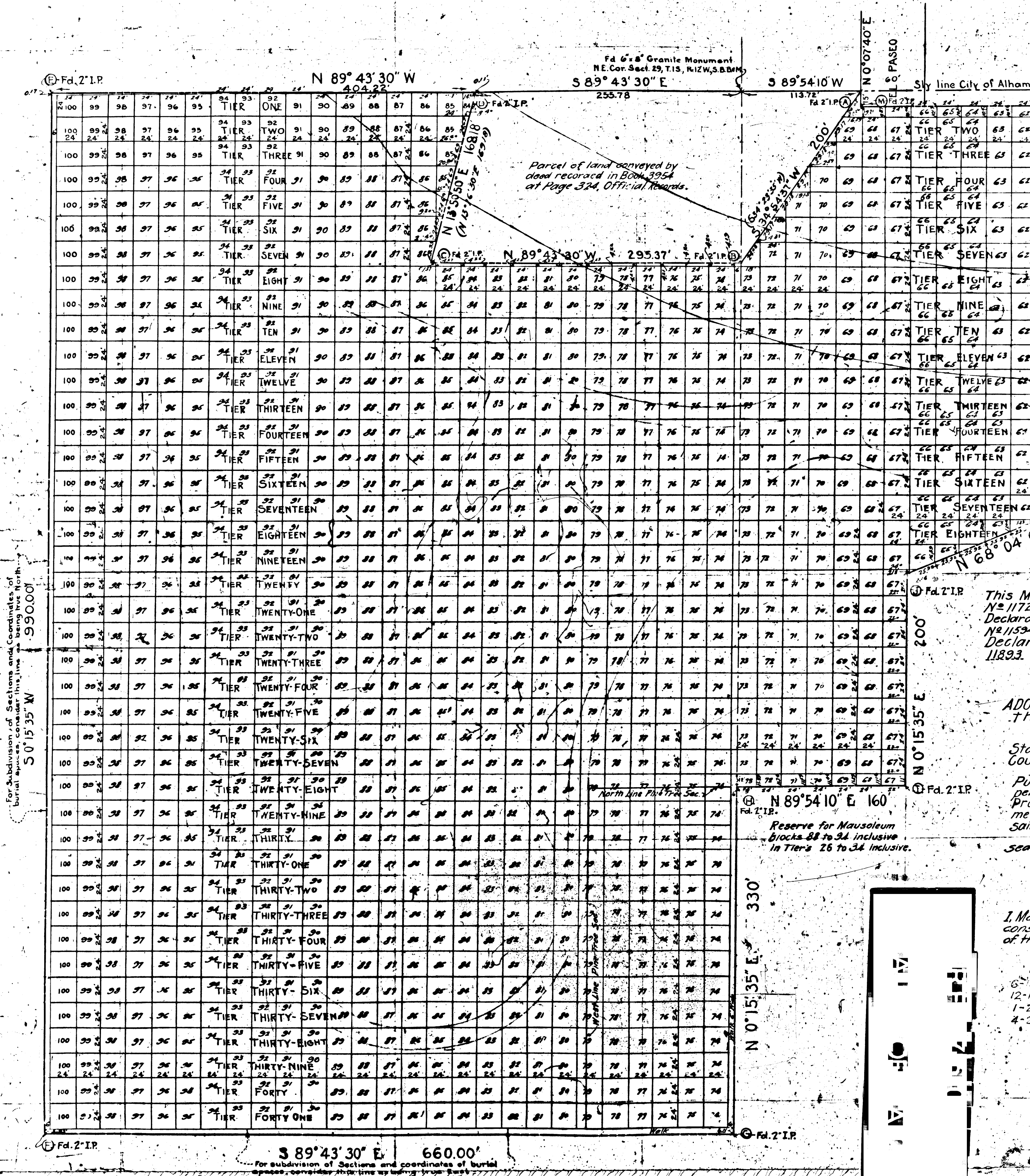


EXCERPT FROM
 Declaration of Dedication of Cemetery Lands recorded December 17, 1932 in Book 11893 at Page 321 Official Records of Los Angeles County, California,
 governing the lands and premises shown upon this map and the use thereof,

4. That they have dedicated and by these presents and the aforesaid survey and map and the filing thereof they do hereby dedicate said lands and premises and the use thereof exclusively to cemetery purposes, reserving, however, unto themselves, their successors or assigns, the right and privilege to at any time and from time to time resurvey, enlarge, replat, alter in shape and/or size, and/or otherwise to or any part of such subdivisions, including the right to modify or change the location of roads and drives and to file amended map or maps thereof specifically reserving the right and privilege to maintain and operate pipe lines, conduits and/or storm drains for sprinklers, drainage and/or
5. That this dedication is and at all times shall be subject to all rules and regulations governing Rainbow Division Memorial Park now in effect, and the adopted and to such conditions and restrictions as to the holding and use of such premises as have heretofore and/or may hereafter be incorporated in conveyances of burial rights in said lands.
6. That this dedication is made and is intended to be made under and in accordance with the provisions of the General Cemetery Act of the State of California.

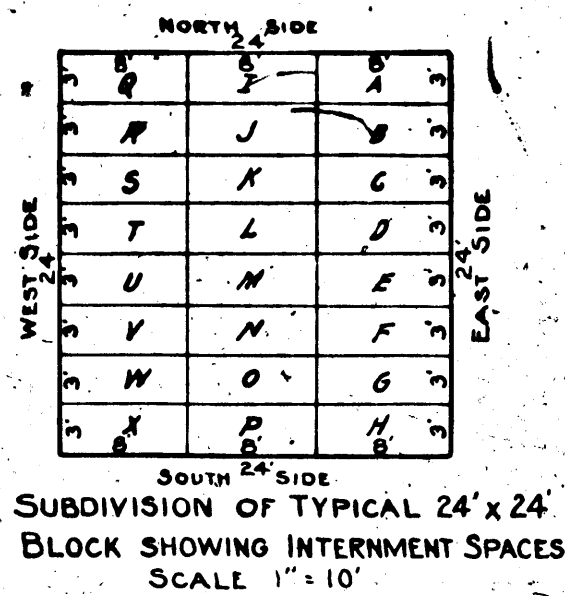

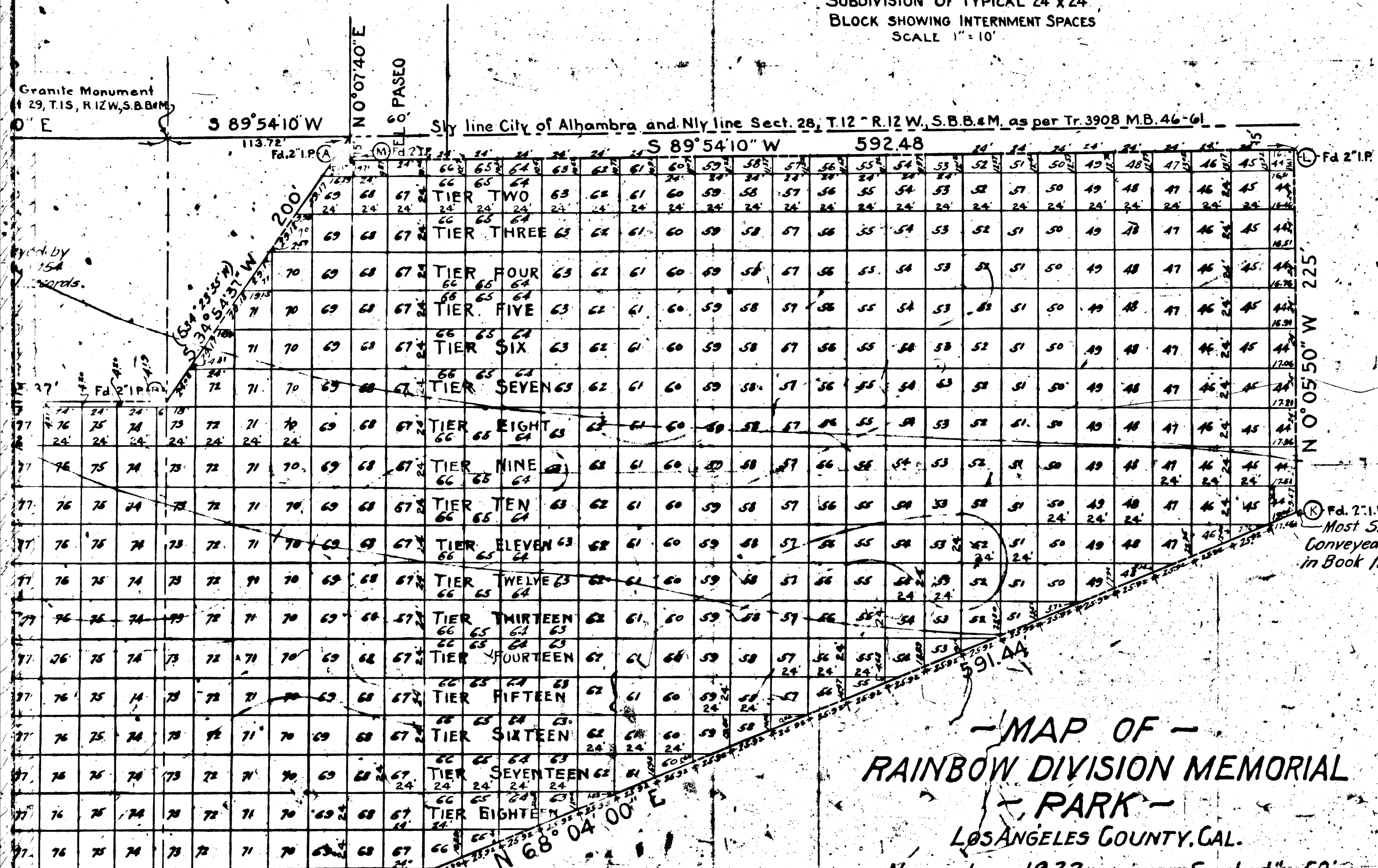
