ANY CHANGE OF LOCATION SHALL BE REQUESTED IN WRITING BY THE OWNER OR HIS REPRESENTATIVE.

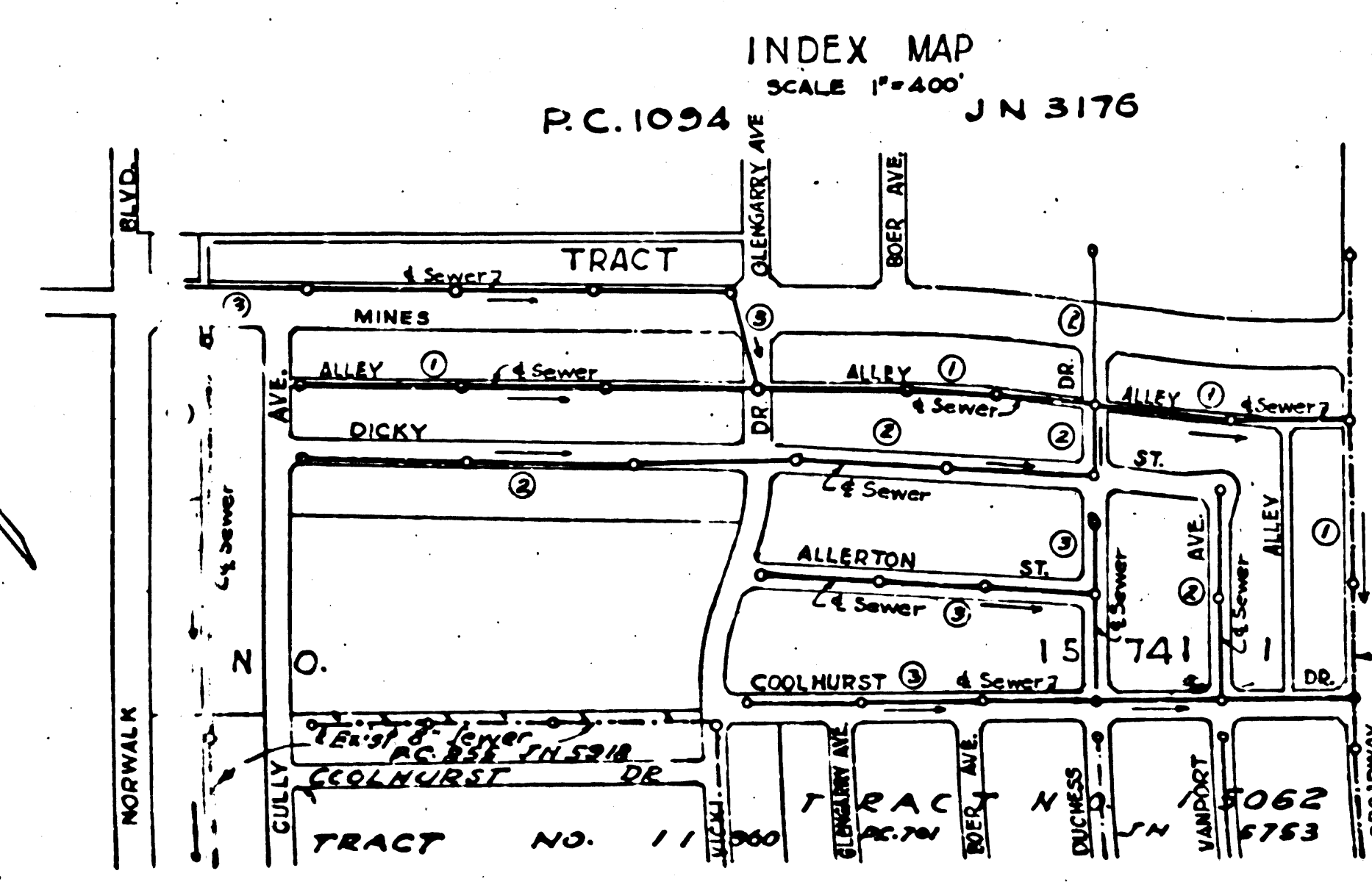
PROFILE ALIGNMENT AND GRADE OF

DATUM OR MEAN SEA LEVEL.
