  2. THE OWNER OR HIS AUTHORIZED REPRESENTATIVE SHALL FURNISH THE COUNTY ENGINEER WITH GRADE SHEETS AND STATIONS FOR ALL HOUSE LATERALS AND BRANCHES AND SHALL PROVIDE STAKES FOR THEM AT THEIR PROPER LOCATIONS WITH STATIONING PLAINLY MARKED. ANY CHANGES IN LOCATION SHALL BE REQUESTED IN WRITING BY THE OWNER OR HIS REPRESENTATIVE.
  3. NO REVISIONS SHALL BE MADE IN THESE PLANS WITHOUT APPROVAL OF THE COUNTY ENGINEER.
  4. USE STANDARD MANHOLE FRAME AND COVERS 5'-6" HT.
  5. USE STANDARD STRENGTH PIPE EXCEPT AS NOTED.
  6. USE CEMENT MORTAR FOR ALL VITRIFIED CLAY PIPE JOINTS.
  7. REINFORCE ALL TRENCH WITHIN RAISED RASCA TO MEET L.A. COUNTY ROAD DEPT. REQUIREMENTS.
  8. ENCASE FOUR FEET OF TOWER AT POINTS OF INTERFERENCE WITH ROADS 5'-6" HT.
  9. HOUSE LATERALS TO BE CONSTRUCTED WITH 1/4" RISE PER FOOT TO PROPERTY LINE EXCEPT AS NOTED.
  10. ALL STRUCTURES SHALL BE BENCH SEWER STRUCTURES 5'-6" DIA. PRODUCED AT RIGHT ANGLES TO THE SEWER LINE AT THE CENTER LINE OF EACH MANHOLE.
  11. FOR LEAKAGE TEST USE FORMULA N1 SPEC'S SECTION 51 10. WIDE TAGS NOT REQUIRED.

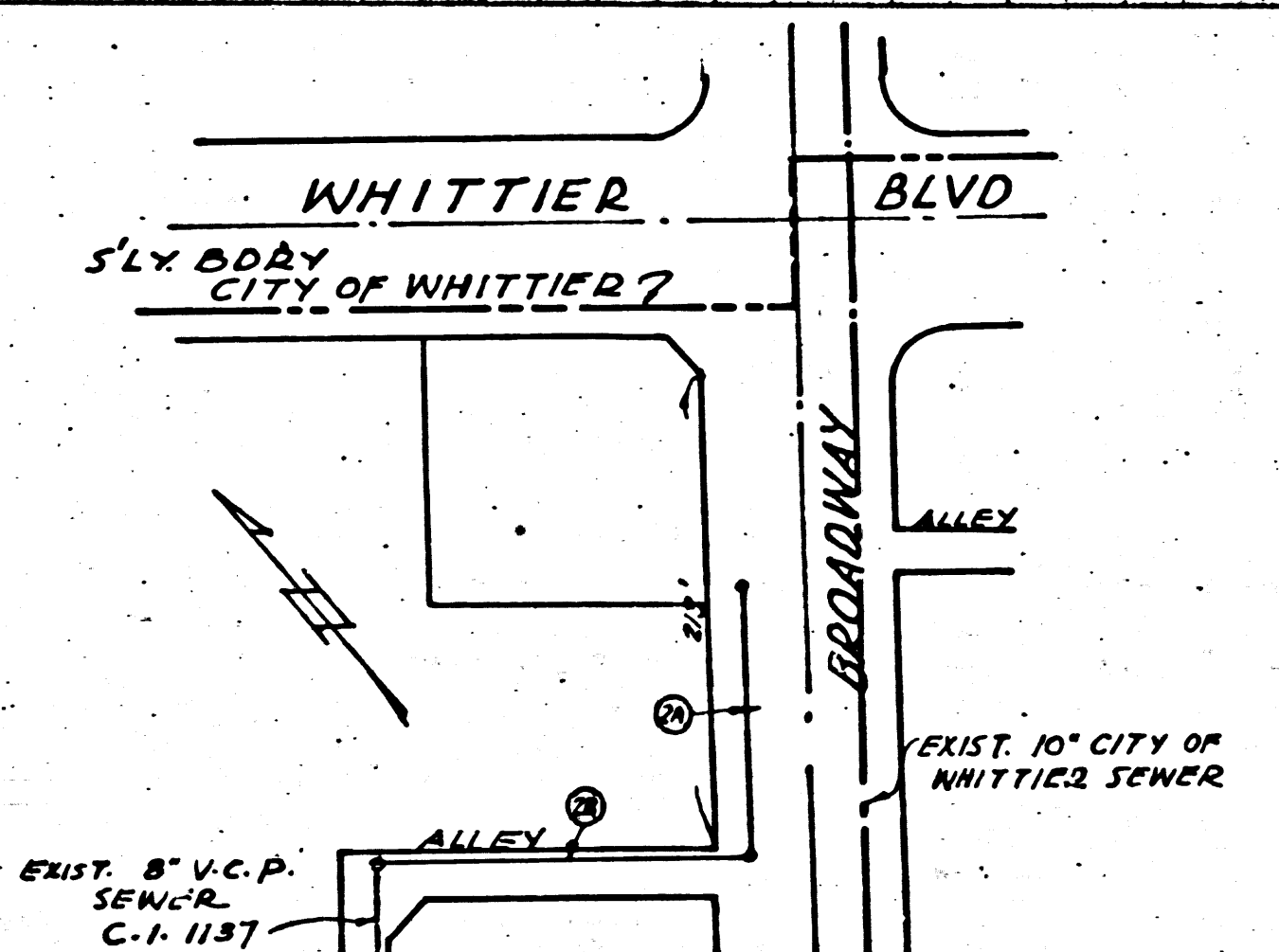

GRADES TO WHICH THIS IMPROVEMENT IS TO BE CONSTRUCTED ARE SHOWN ON PLANS AND PROFILES. GRADE POINTS FOR TOP OF CURB, CENTER LINE OF STREET, OR CENTER LINE OF ALLEY ARE SHOWN BY CIRCLES ON PROFILES. AT ALL POINTS BETWEEN DESIGNATED POINTS THE GRADE SHALL BE ESTABLISHED SO AS TO CONFORM TO A STRAIGHT LINE DRAWN BETWEEN SAID DESIGNATED POINTS. ELEVATIONS ARE IN FEET ABOVE U.S. 65' DATUM OR MEAN SEA LEVEL.

THIS DRAWING AND THE DATA HEREON ARE HEREBY MADE A PART OF THE SPECIFICATIONS. 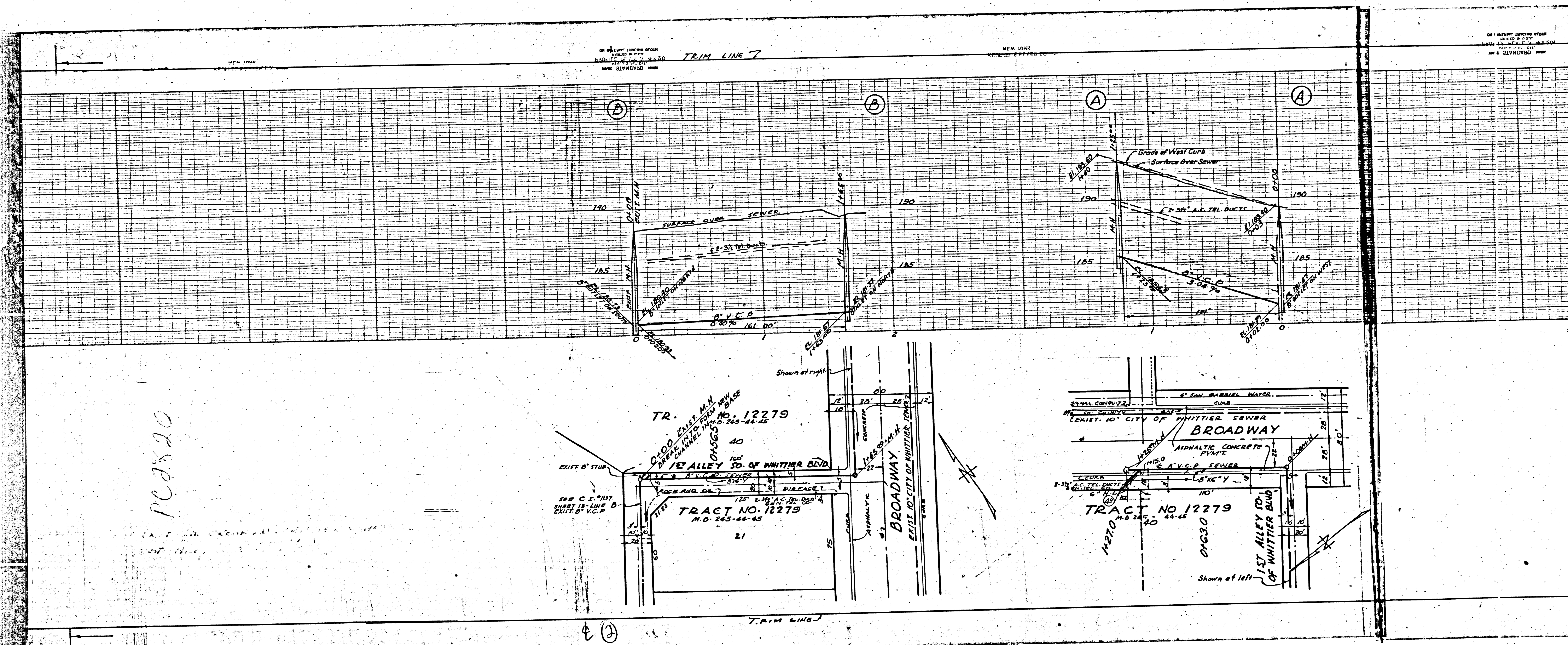
