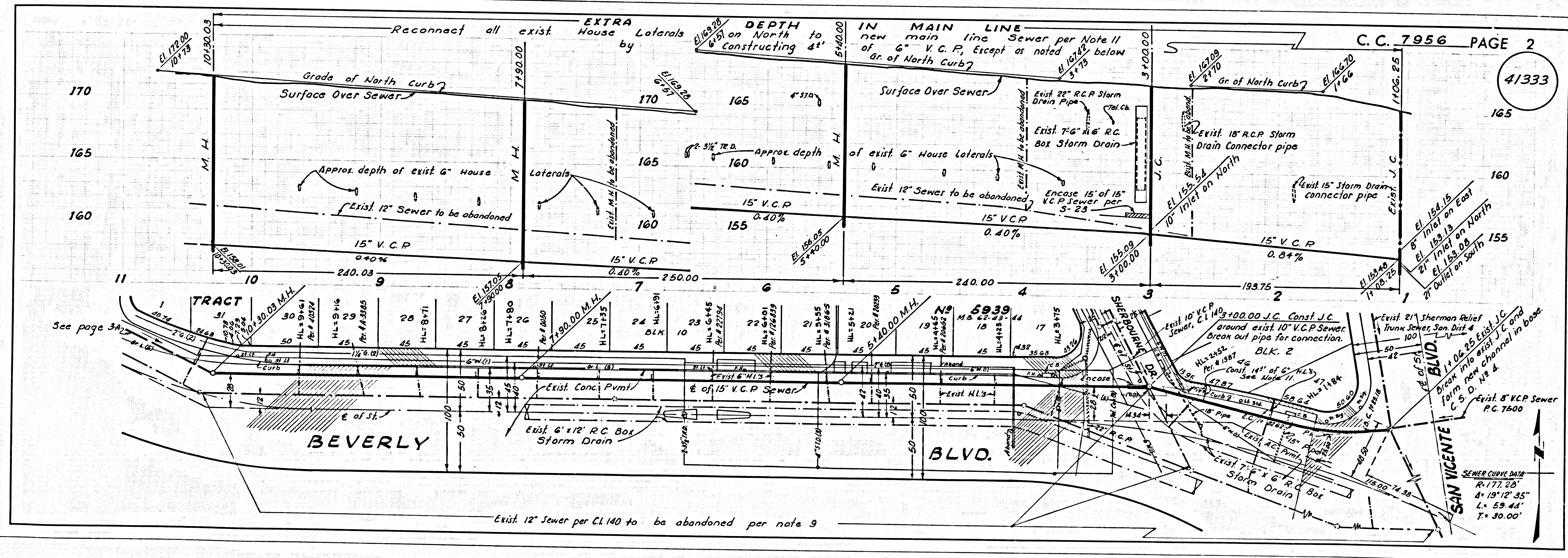

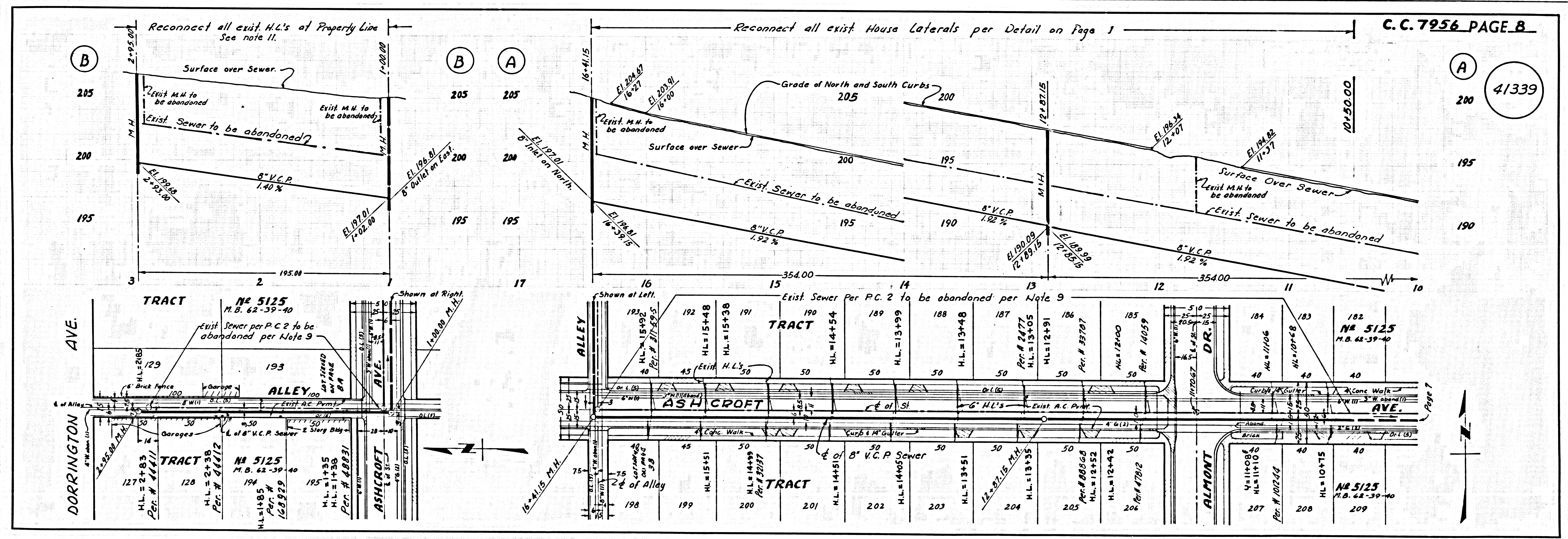
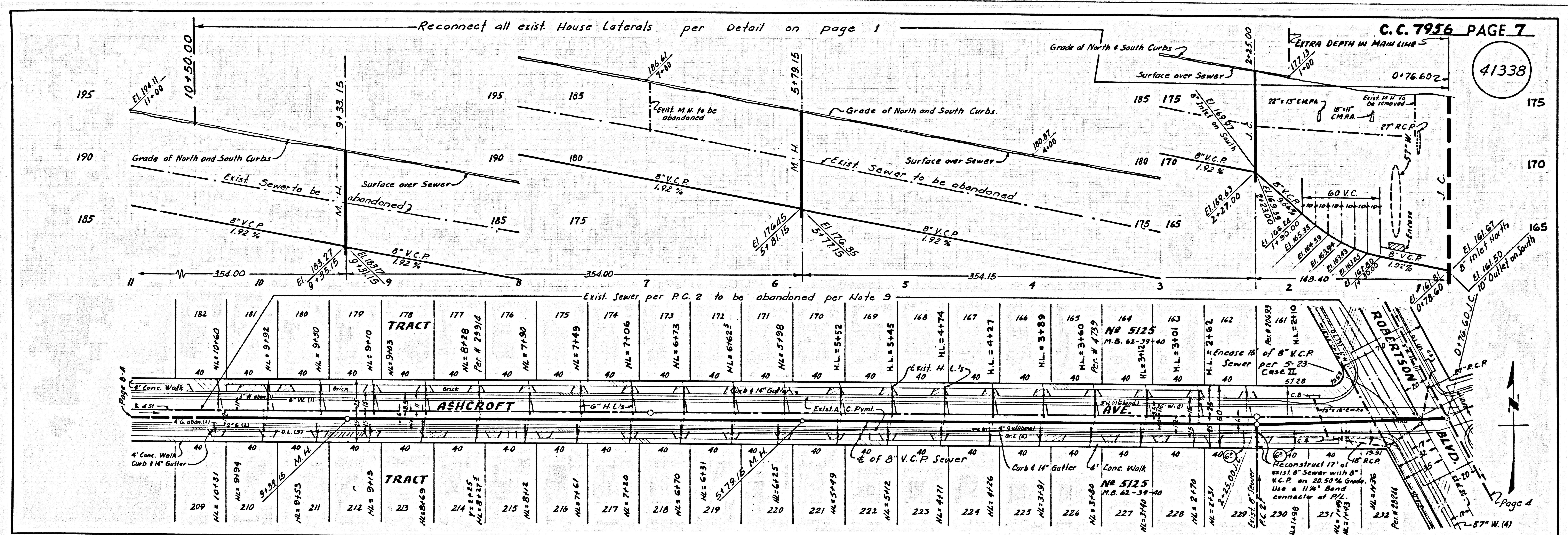
TYPICAL DETAIL

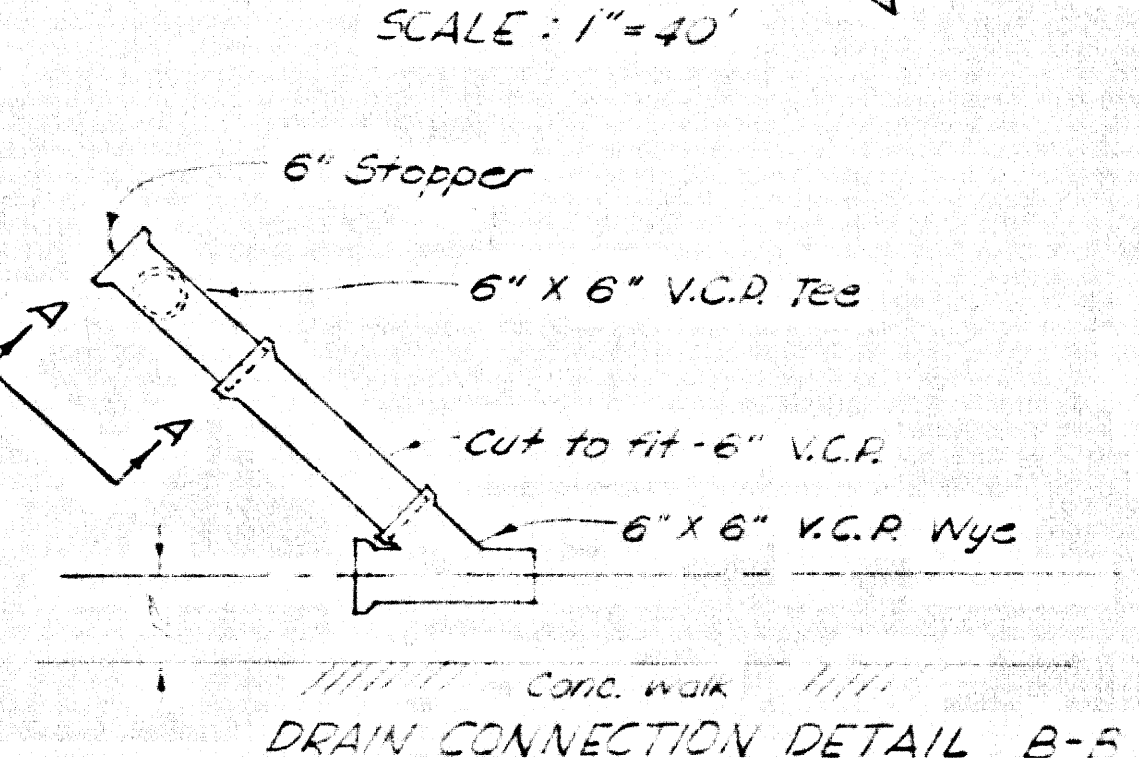
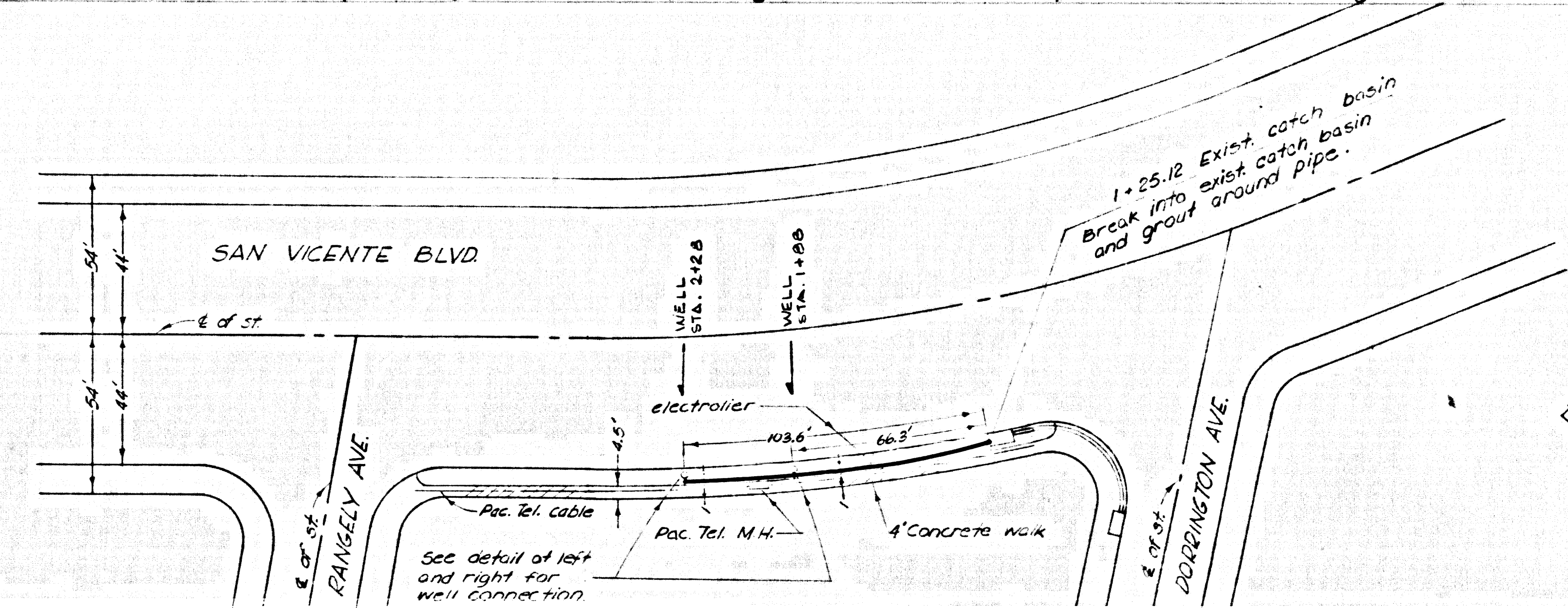
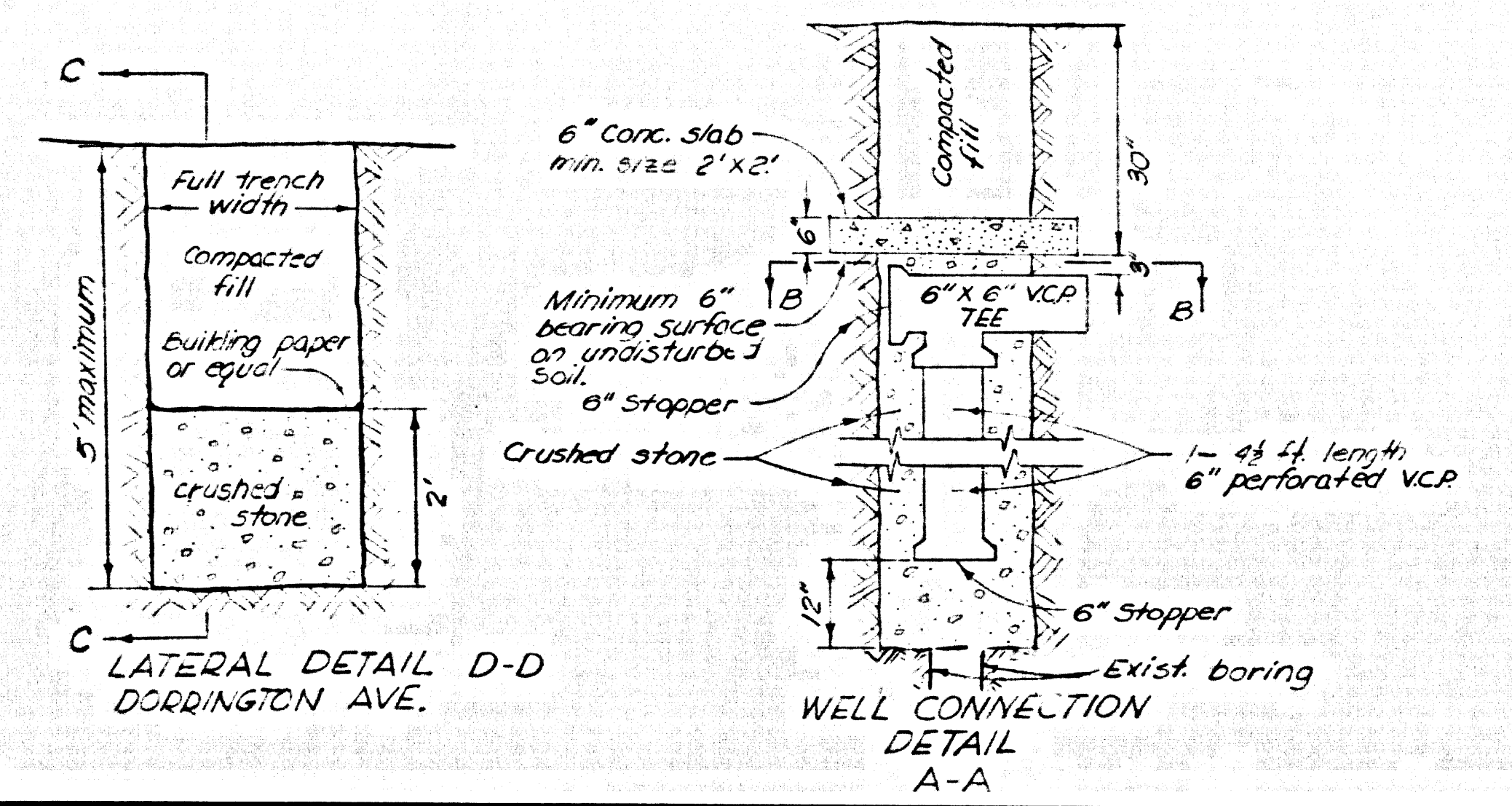


9. All concrete sidewalks, driveways, curbs and gutters cut or damaged during construction shall be replaced in accordance with Los Angeles County Road Department requirements.
10. The following latest revised Sta. Plans on file in the Office of County Engineer shall apply in the construction of this project: S-1, S-2, S-21, S-20, and S-53.

NOTE

1. Prior to construction, the Contractor shall secure a Fee-exempt amended Road Permit, County Road Department, 5550 W. 63rd St., Los Angeles, 90045.
2. The Contractor shall notify the Construction Division by telephone (MADison 9-4747, ext. 3155) at least 48 hours before starting any work under this contract.
3. All crushed stone to be Aggregate No. 3 per Section 500-14 of Standard Specs.
4. No revision shall be made in these plans without the approval of the County Engineer.
5. Refer to sec. 718.01 of the S.M. Specs. Regarding Safety Signs.
6. Prior to construction, the contractor shall secure a fee exempt construction permit, County Engineer, Construction Division, Room 501 105 W. 6th St., L.A. 90012.
7. Street resurfacing methods shall be in accordance with Sec. 306-112.0 of spec. Provisions. Final street resurfacing in any location shall be completed within 30 days after completion of Street Excavation. The resurfaced area shall be sealed with R-1 Emulsion and 1/2" crushed rock.
8. Resurfacing areas within 10' of any 4" to 12" of 7.5% asphalt concrete on 5" inches of aggregate base materials.
