**WATER POLLUTION CONTROL REQUIREMENTS FOR SEWER CONSTRUCTION**

1. Excavated sediments and other pollutants must be retained on site and may not be transported from the site. The site must be stabilized to prevent erosion and sediment transport.
2. The site must be stabilized to prevent erosion and sediment transport.
3. Erosion control measures shall be installed and maintained throughout the construction period.
4. Sediment basins shall be installed to capture and settle suspended solids.
5. Stormwater runoff shall be managed to prevent pollution of adjacent waters.
6. Construction activities shall be restricted to avoid disturbing riparian areas.
7. Any silt or sediment that is discharged into adjacent waters must be removed.
