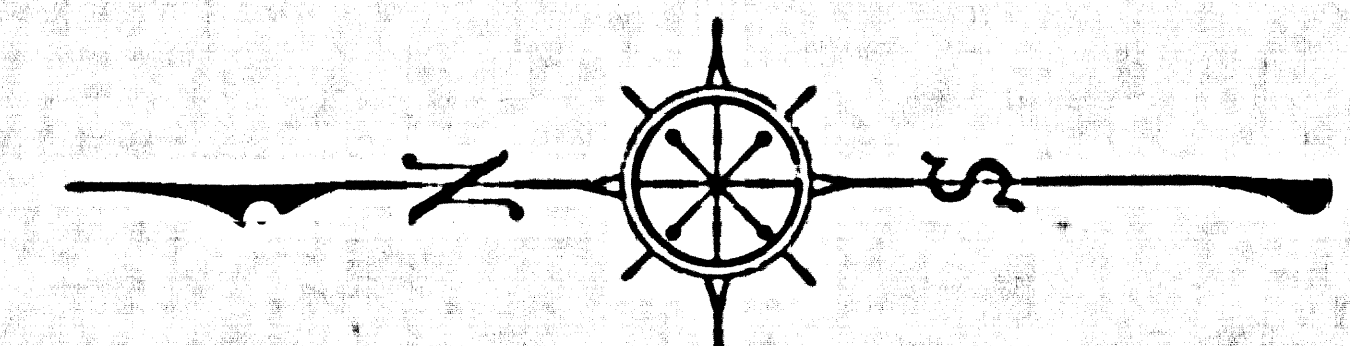

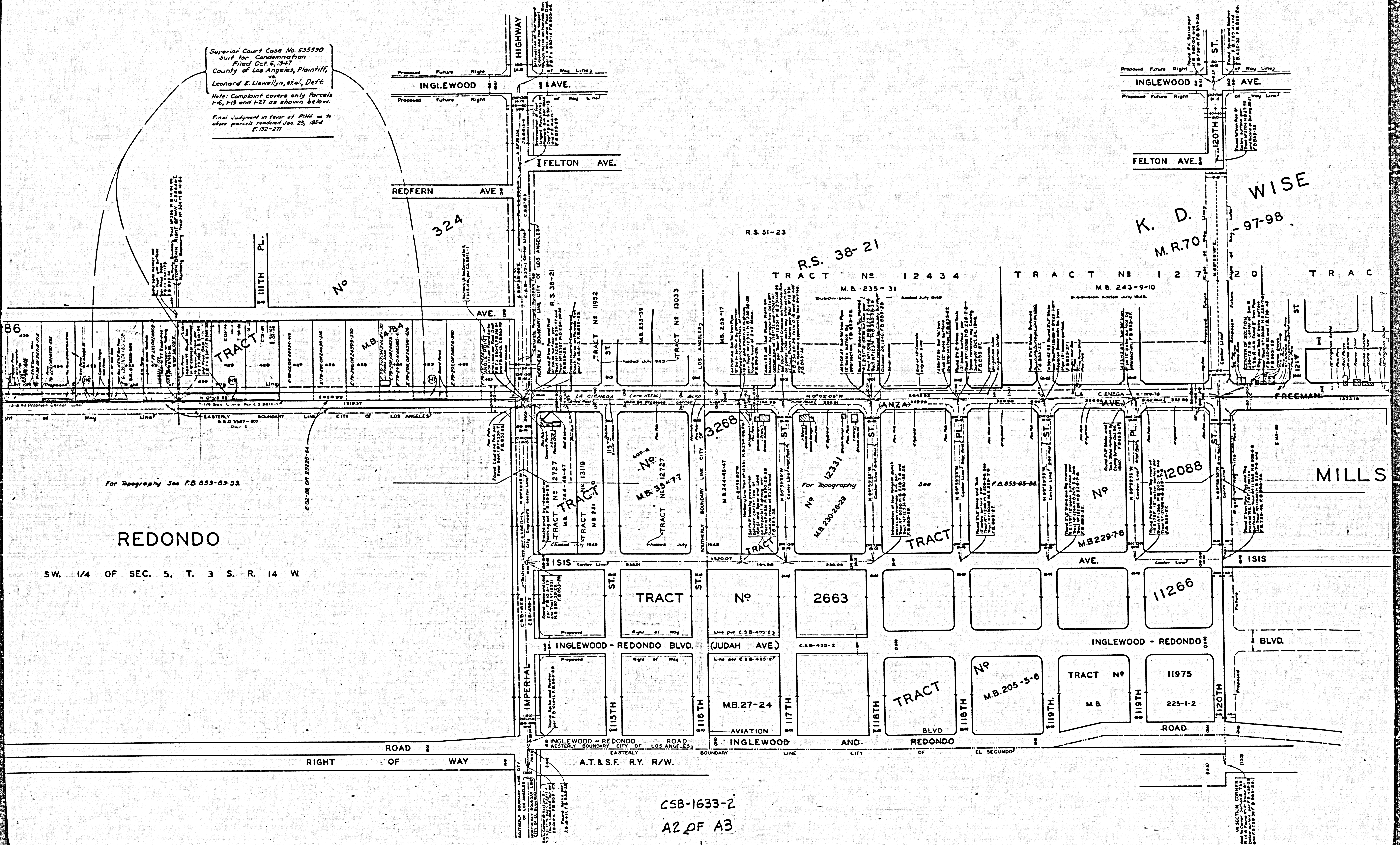
MAP OF

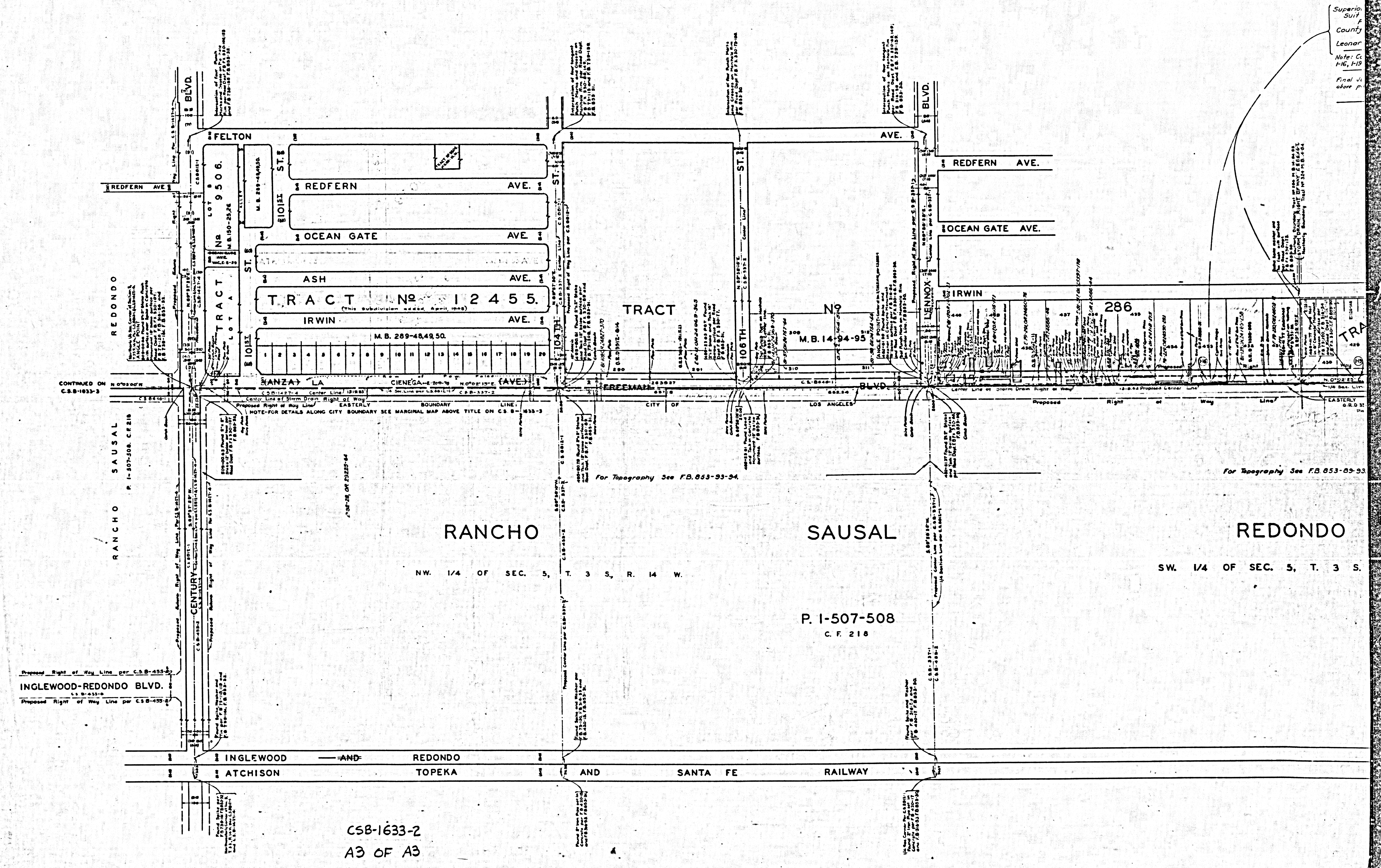
