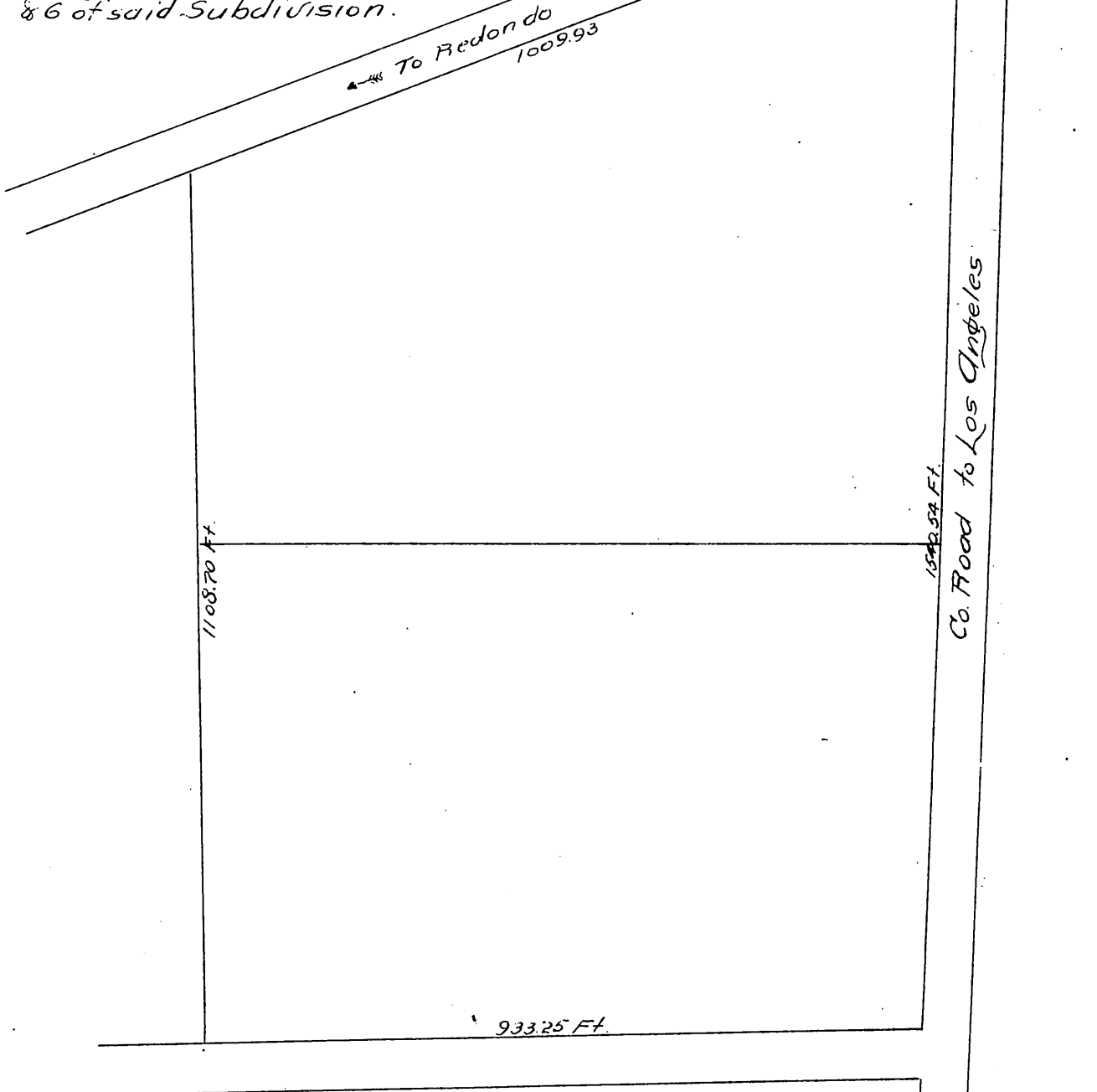


Map of WRIGHTS SUBDIVISION

Wednesday March 8 1893 Board met pursuant to adjournment present Supervisors Cook, Forrester, Francisco, Hanley and Hay and the Clerk.

In re Vacation of Streets and Reversion to Acreage }
Lots in Wright's Sub. of the McDonald Tract, Ocean Road Dist. } This matter having been regularly set for hearing at this time and due notice thereof having been given and the matter coming regularly before the Board, the petition being read A. M. Carpenter Esq. appearing on behalf of the petitioners, there being no objections filed, and Messrs A. M. Carpenter, M. N. Sheldon and T. S. Ewing being sworn and testified it is moved by Supervisor Hay duly carried and ordered that the prayer of the petition be granted, as follows, viz: Vacating Streets No 1, 2 and 3 of said tract as per map on file with this Board and reverting said property to acreage, but denying said petition as to the vacation of the streets lying north and south of said tract. The portion of this petition which is granted is conditioned upon the petitioners filing with the County Recorder a map showing such reversion.
