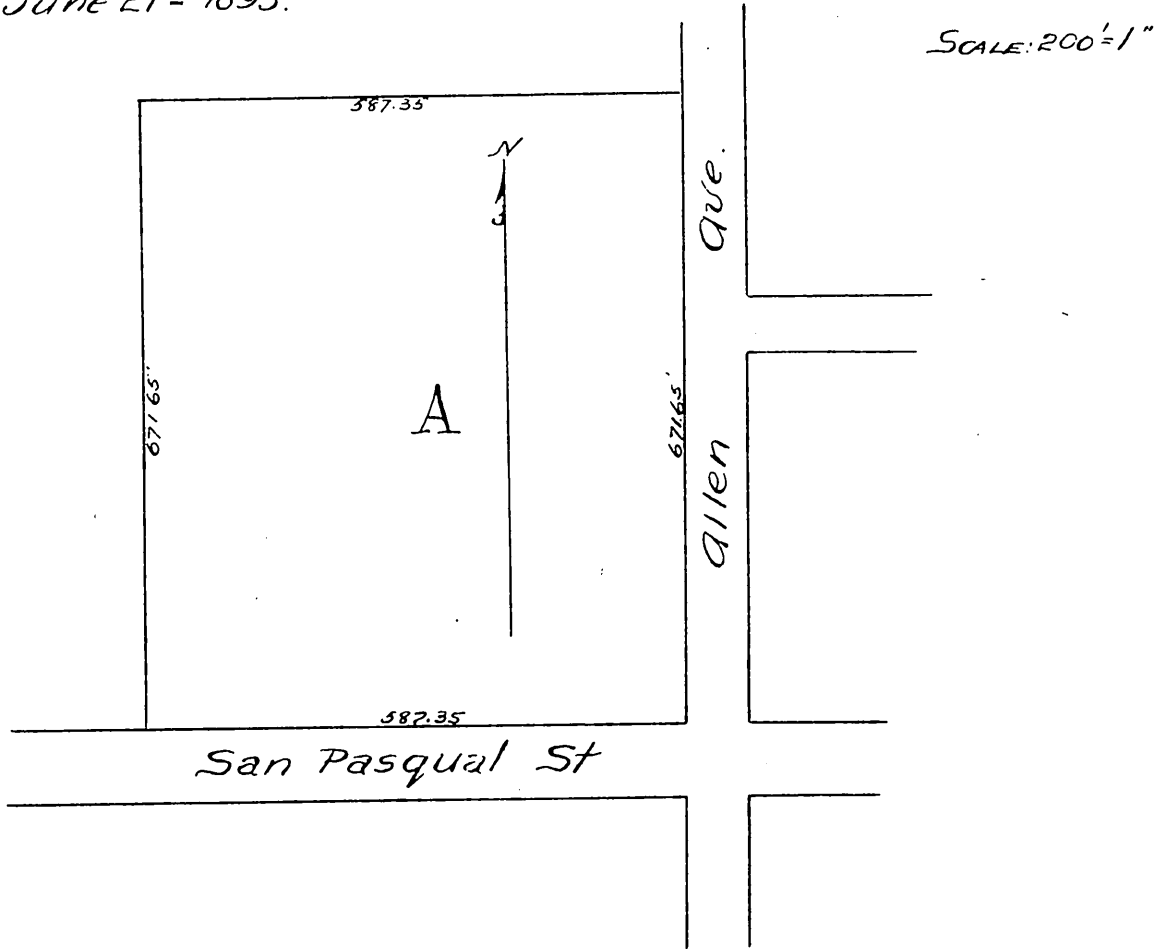




Plat

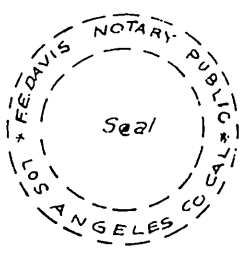

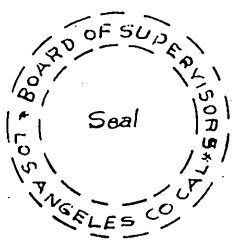
In Re Vacation of Barcelona Street Whitaker's Sub-division of Marceline.
