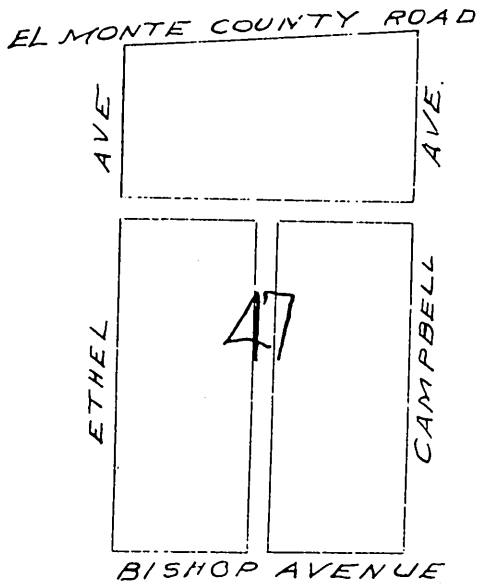




Map

Alleys Block 47 Ramona

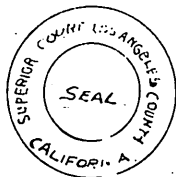
