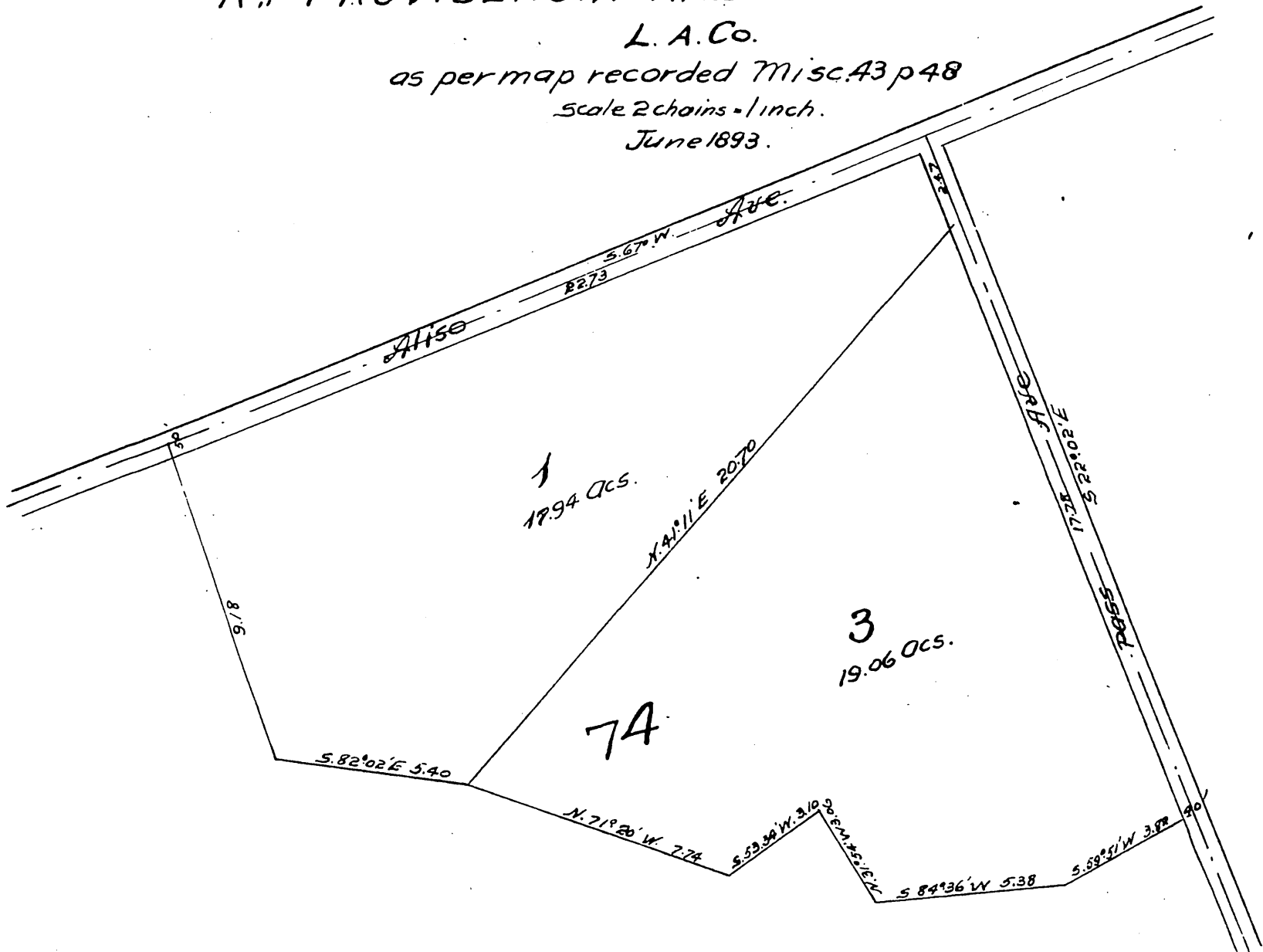




Re Plat

Baker is sworn and examined, and upon motion of Supervisor Stanley, duly seconded and carried, it is ordered that Olive Avenue, from Aliso Avenue to the Laguna Reservation, excepting that portion of same crossing Pass Avenue, as per map, recorded in Book 43 pages 47 et seq. of Miscellaneous Records of Los Angeles County, be and the same is hereby ordered and declared vacated and abandoned upon the filing of a map showing all property as affected by said vacation reserving however, the right to reoccupy said property for road purposes whenever the Board of Supervisors deem the same desirable, without cost to the County.
