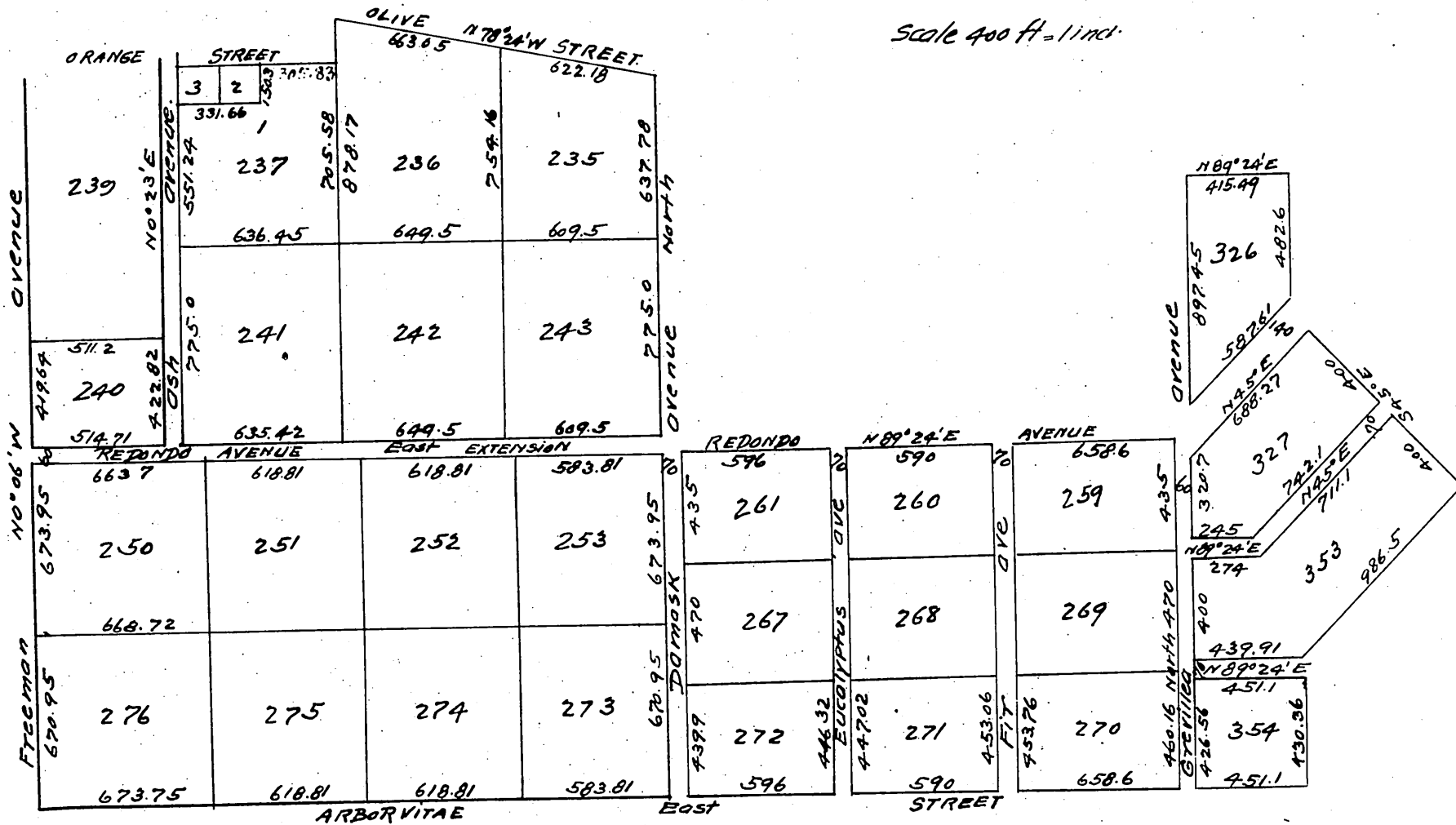


Replat of

 adjourned meeting of the Board of Supervisors, Present the full Board and the Clerk
 in re vacation of certain streets in the
 South-westerly part of the Townsite of Inglewood } This being the time regularly set by order of this Board and publication of notice
 thereof for hearing the petition of W. J. Thomas et al, herein, D. Freeman appears
 and is sworn and examined, and, no protest against such vacation having been filed, upon motion of Supervisor May, duly se-
 -conded and carried, it is ordered that the following described streets as shown on the map of the Townsite of Inglewood, recorded
 August 20th 1888, in Book 34 of Miscellaneous Records of Los Angeles County, California Pages 19 et seq viz Ash Avenue from Arbor-
 -vitae Street to Mango Street, Birch Avenue from Arbor Vitae Street to mango Street, Celosia Street from Arbor Vitae Street to Redon-
 -do Avenue, Dahlia Street from Arbor Vitae Street to Buckthorn Street, Lemon Street from Freeman Avenue to Celosia Street Ce-
 -dar Avenue from Redondo Avenue to Olive Street, Buckthorn Street from Freeman Avenue to Grevillea Avenue, Catalpa Street
 from Saffron Avenue to Grevillea Avenue, Mango Street from Freeman Avenue to Damask Avenue, Nectar Street from Freeman
 Avenue to Redondo Avenue, Nectarine Street, from Cedar Avenue to Damask Avenue, Redondo Avenue from Orange Street to
 Damask Avenue, Saffron Avenue from Ash Avenue to Damask Avenue, Terebinth Avenue from Nectar Street to Buckthorn Street
 the easterly 140 feet of Grevillea Avenue from Mango Street to Redondo Avenue the easterly 80 feet of Grevillea Avenue
 from Arborvitae Street to Redondo Avenue be and the same are hereby vacated and abandoned, conditioned upon the
 filing with the County Assessor and the recording in the office of the County Recorder of a map showing all Property
 affected by this order.
