

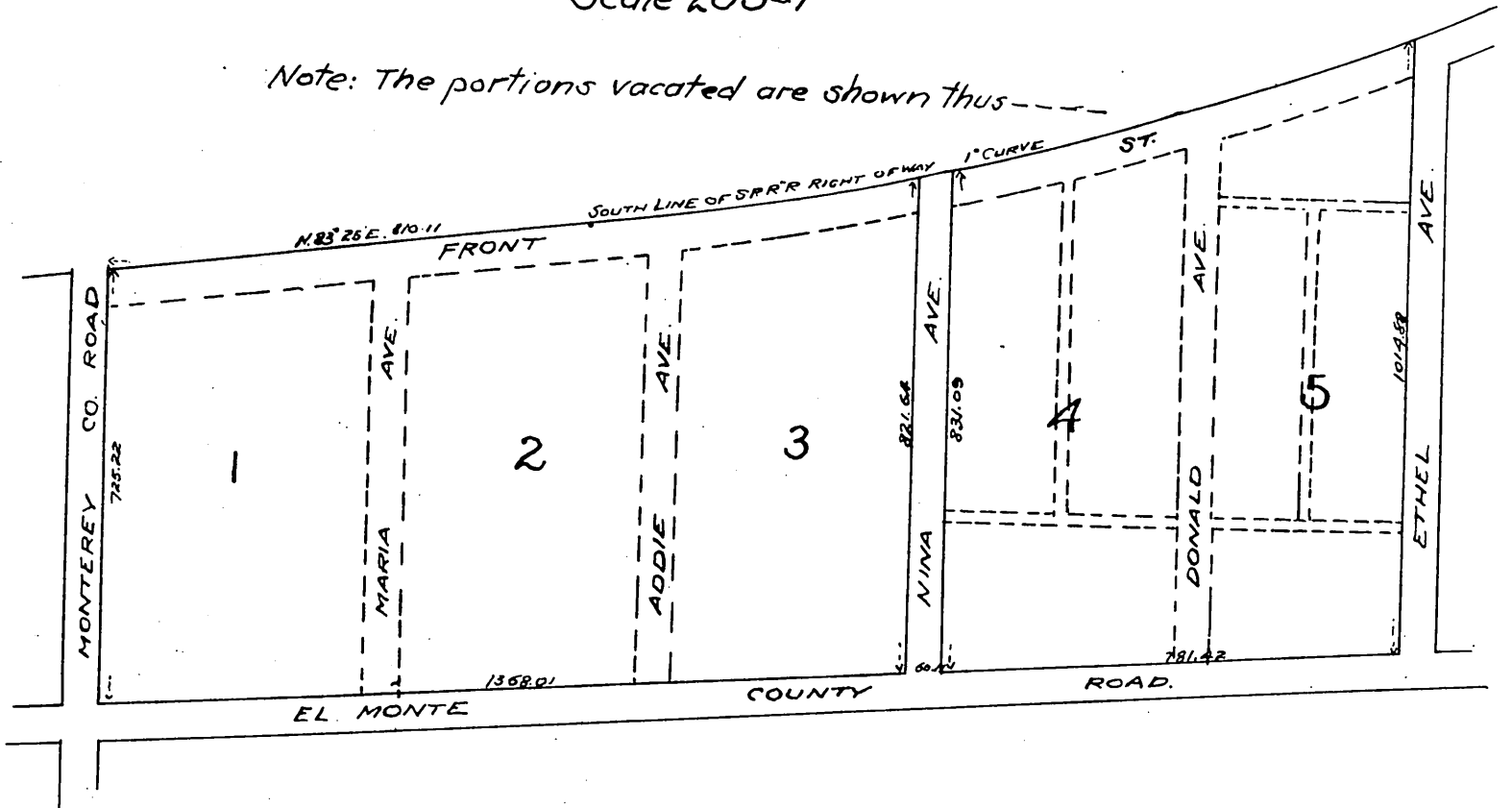


MAP

Regular meeting of the Board of Supervisors Present Supervisors E. S. Field, Chairman presiding O. W. Conden, Geo. Alexander, P. J. Wilson and James Hankey, and C. W. Bell, Clerk, by R. Williams deputy.

In re Vacation of Streets in Ramona)
Alhambra Road District.)
Petition of H. E. Huntington, et al)

This being the time regularly set
by order of this Board, and publica-
tion of notice thereof for hearing the

petition herein, the matter is called up, and no protest having been filed;
Upon motion of Supervisor ~~Conden~~, duly seconded and carried, it is or-
dered that Maria Avenue, Addie Avenue and Donald Street, from the northerly
boundary line of El Monte County Road to the southerly boundary line of Front
Street; and all of Front Street from the easterly line of Monterey County Road
(now known as Fair Oaks Avenue) to the westerly line of Nina Street extend-
ed north to the southerly line of right of way of S. P. R. R. and from the east-
erly line of said Nina Street extended north to the southerly line of right of
way of S. P. R. R. to the westerly line of Ethel Street extended north to the
southerly line of right of way of S. P. R. R.; and all the alleys in Blocks Four
(A) and Five (S), all said streets, avenues and alleys being in a subdivision
known as "Ramona" a map of said subdivision being recorded in book 12,
page 54, Miscellaneous Records of Los Angeles County, be and they are here-
by vacated and abandoned and the land therein contained restored to acreage.

This order is conditioned upon the petitioner herein filing for record in
the office of the Recorder of Los Angeles County a certified copy hereof, to-
gether with a map showing all property affected thereby.
