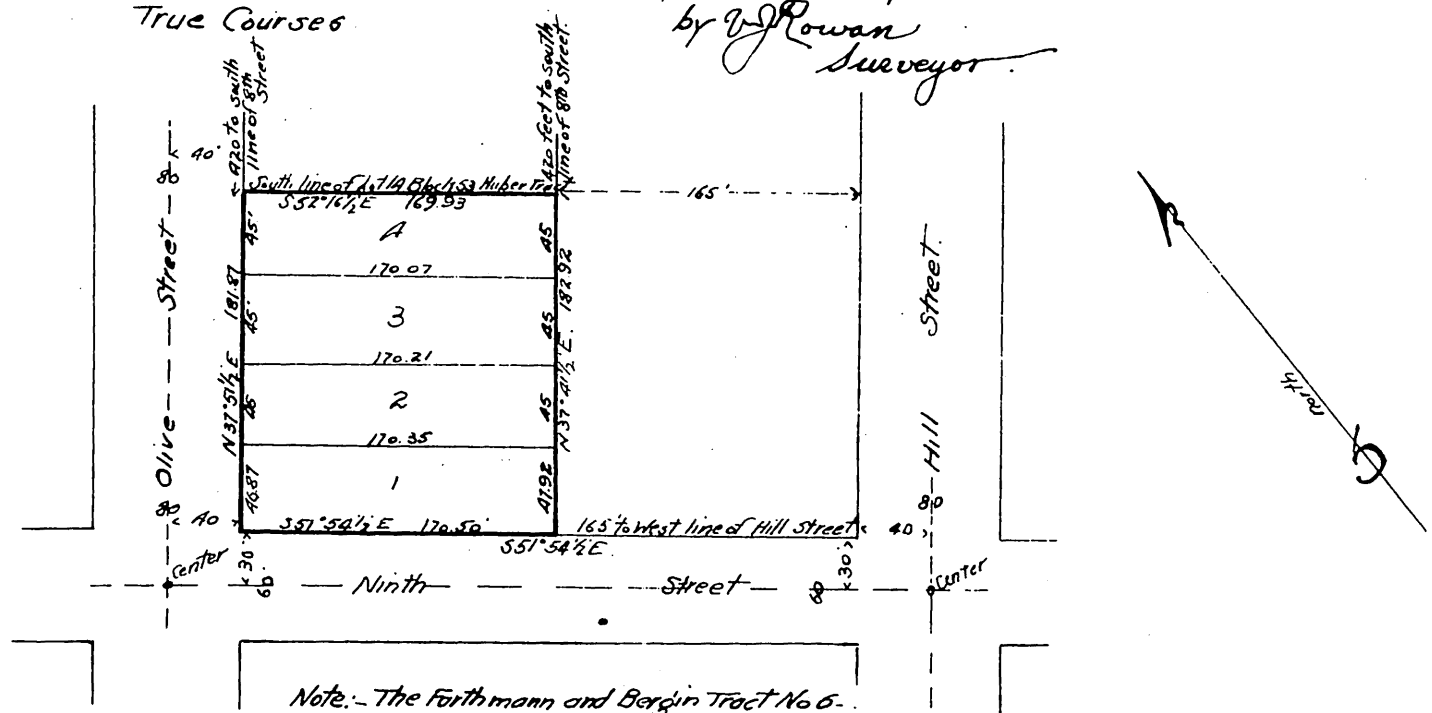


Map of

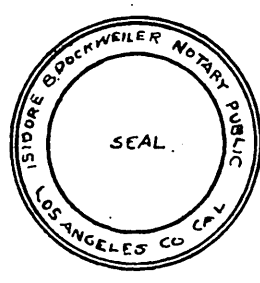
