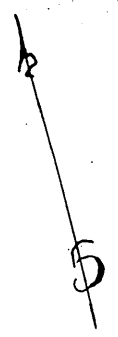
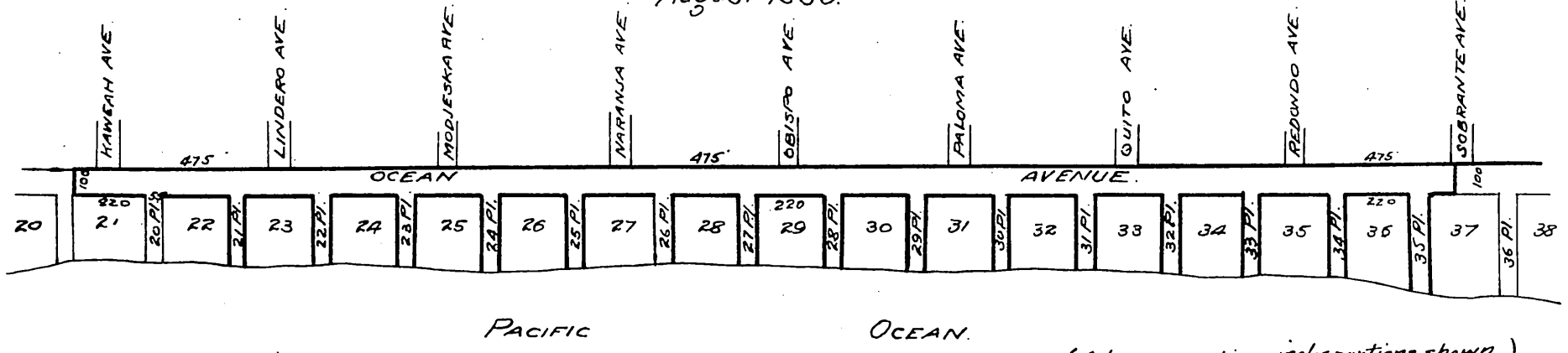


ALAMITOS BEACH TOWNSITE

This being the time regu-

of this Board for hearing herein, the matter is taken up, and no protests
having been filed.

Upon motion of Supervisor Wilson, duly seconded and carried, it is
ordered that Ocean Avenue from the east line of 20th Place to the west
line of Sobrante Avenue; and 21st 22nd 23rd 24th 25th 26th 27th 28th
29th 30th 31st 32nd 33rd 34th and 35th Places, from the south line of
Ocean Avenue to the shore of the Pacific Ocean, be and they are hereby va-
cated and abandoned, and the land therein contained restored to acreage.

together with a map showing all property affected thereby

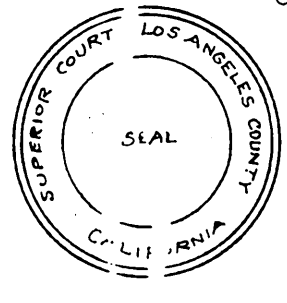
