Upon motion of Supervisor Wilson, duly seconded and carried, it is

ordered that the following be and the same is hereby adopted:

Whereas on September 2nd 1902, this Board, by an order duly adopted, vacated and abandoned certain streets and avenues in the town of Port Ballona, on the condition that a map of said lands be filed with this Board showing streets and avenues to be dedicated as public highways, the same to take the place of the streets and avenues asked to be vacated; and

Whereas The Beach Land Company has filed with the Clerk of this Board a map of the Playa del Rey Townsite, showing streets and avenues to be dedicated to public use and to take the place of the streets and avenues heretofore vacated, to-wit: September 2nd 1902; therefore be it

Resolved, that the order of vacation heretofore made by this... Board, to-wit: September 2nd 1902, vacating certain streets and avenues in the Town of Port Ballona be and the same is hereby made absolute.
