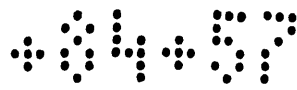
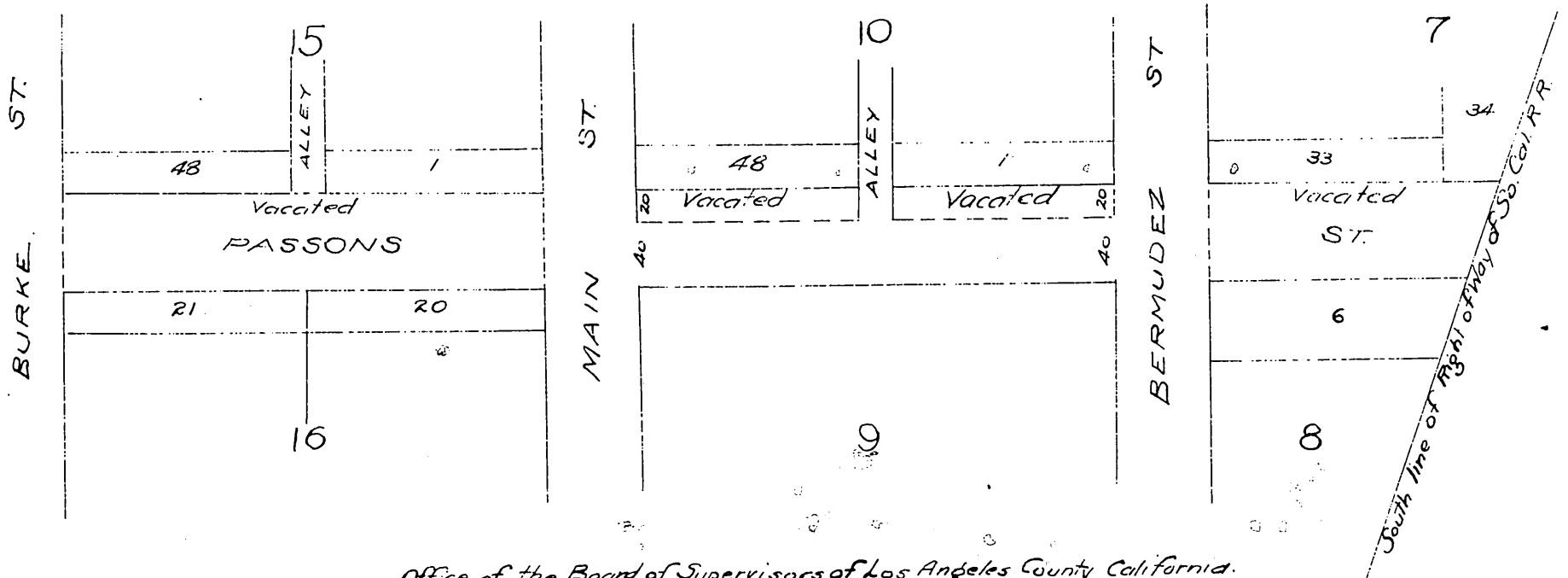


MAP

Board and publication of notice thereof for hearing the petition for the  
 vacation and abandonment of a portion of Passons Street <sup>in the town of Rivera</sup> the matter  
 is called up, and no protests having been filed, S. W. Burke is duly sworn and  
 examined, and upon motion of Supervisor Longden, duly seconded and carried,  
 it is ordered that Passons Street in the town of Rivera, from the south  
 line of the right of way of the Southern California Railway Company to the  
 north line of Bermudez Street, and from the south line of Main Street to  
 the north line of Burke Street, and the west twenty (20) feet of said street  
 lying between the south line of Bermudez Street and the north line of  
 Main Street, be and the same is hereby vacated and abandoned and the  
 land therein contained restored to acreage.

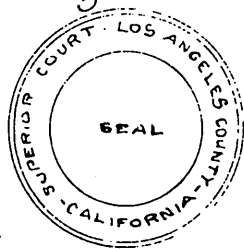
This order is conditioned upon the petitioners filing for record in the
