In Re Vacation of Certain Streets in Watt's Subdivision }
Los Angeles Road District.

It is ordered that the following described public highways situate, lying and being in the Los Angeles Road District, County of Los Angeles, State of California to-wit: "First: All that certain road shown upon the Map of Watt's Subdivision of a part of the Rancho San Rafael, as per Map of said Subdivision recorded in Book 5 of Miscellaneous Records of Los Angeles County, California, at pages 200 and 201 thereof, said road having a bearing of South 14° West and being bounded on the Easterly side by Lots 50, 51 and 52 of said Watt's Subdivision and by the Gates Tract, and on the Westerly side by Wooley's Subdivision of Lot 49 of Watt's Subdivision of a part of San Rafael Rancho and by a Subdivision of Lot 48 of Watt's Subdivision of a part of the Rancho San Rafael and by the Subdivision of Lot 47 of Watt's Subdivision of a part of the Rancho San Rafael and said road extending from the south line of said Watt's Subdivision to the Southerly line of that certain County road along the Southerly boundary of Eagle Rock, sometimes known as and called Eagle Rock Road. The above described road running in a general Northeasterly and Southwesterly direction. Second: All of that certain road situated in Section 35 T.1.N., R. 13.W., S. B. M., extending from the South line of Watt's Subdivision of a part of the Rancho San Rafael, Southerly to the Northerly line of Glassell Road, having a bearing of South 5° 45' West and being shown upon that certain Map on file in the office of the County Surveyor of the County of Los Angeles, State of California, said Map being numbered 3472, said road running in a general Northeasterly and Southwesterly direction. Third: All of that certain road shown upon the map of Watt's Subdivision of a part of the Rancho San Rafael as per map recorded in Book 5 of Miscellaneous Records of Los Angeles County, California, at pages 200 and 201 thereof, bounded on the Southerly side by Lots 50, 54, and 55 of said Watt's Subdivision and on the North by the Westerly part of Lot 59 and Lots 60, 61 and 62 of said Watt's Subdivision and by Lots 1 and 2 of Eagle Rock, as per map recorded in Book 31 of Miscellaneous Records of Los Angeles County, California, at page 88 thereof, and by Lots 1, 2, 3, and 4 of M^{rs} Koon & Strong's Subdivision of Lots 3 and 4 of Eagle Rock and extending from a straight line drawn from the Southwesterly corner of said Lot 4 of M^{rs} Koon & Strong's Subdivision to the Northeast corner of Lot 4 of Wooley's Subdivision of Lot 49 of Watt's Subdivision of a part of San Rafael Rancho, North 88° 08' East to the Easterly line of Lot 55 of said Watt's Subdivision, Said road running in a general easterly and westerly direction and being sometimes known as and called Eagle Rock Road, as will more fully appear by reference to map hereto attached and made a part hereof, be and the same are hereby vacated and abandoned and the lands therein contained restored to acreage.
