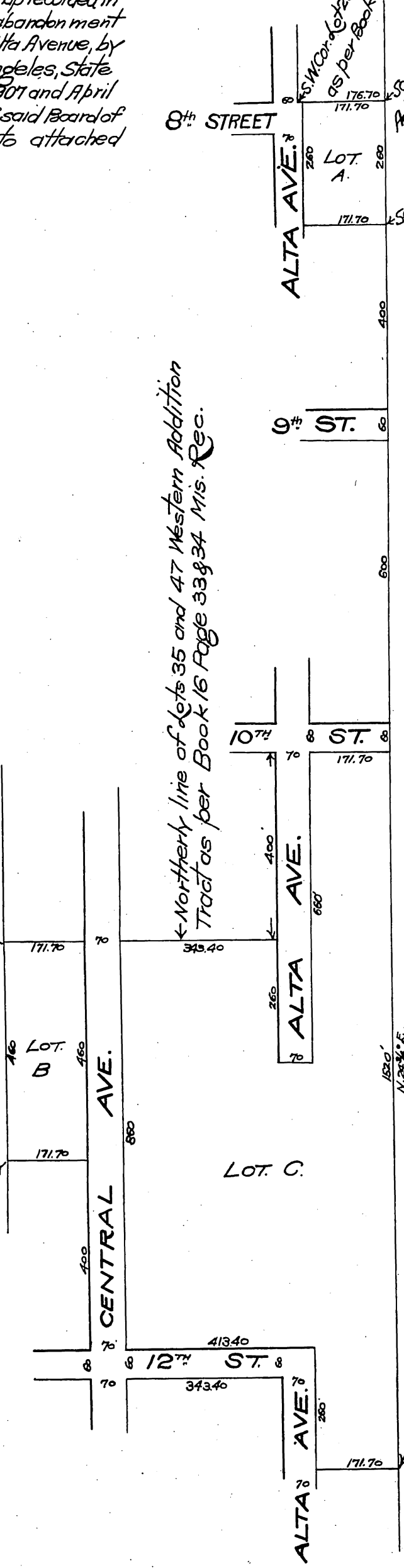

Recorder of Los Angeles County, which lies between the South line of 11th Street and the
North line of 12th Street; - said foregoing 5-foot strips of land also being a portion of
Alta Avenue --
