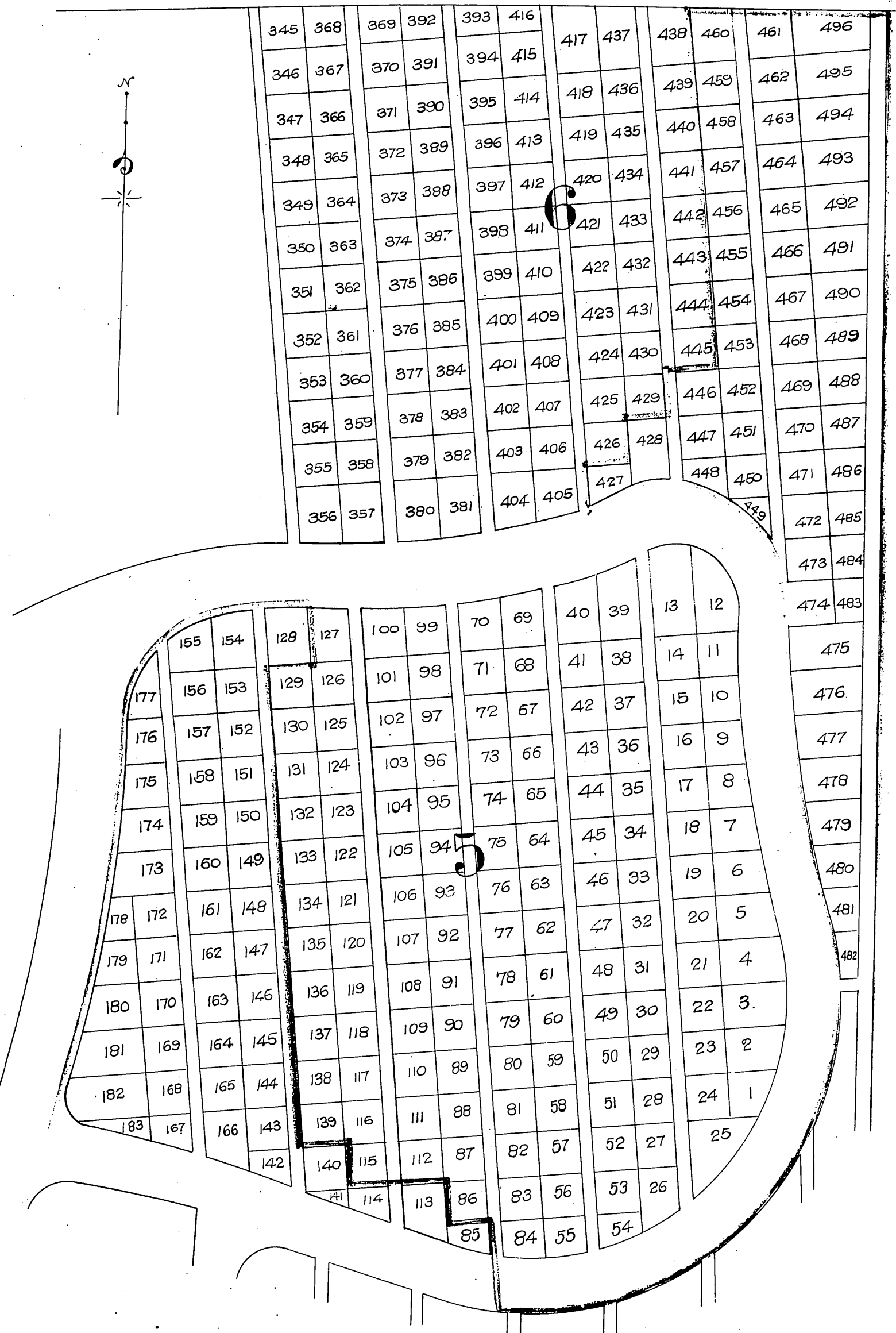
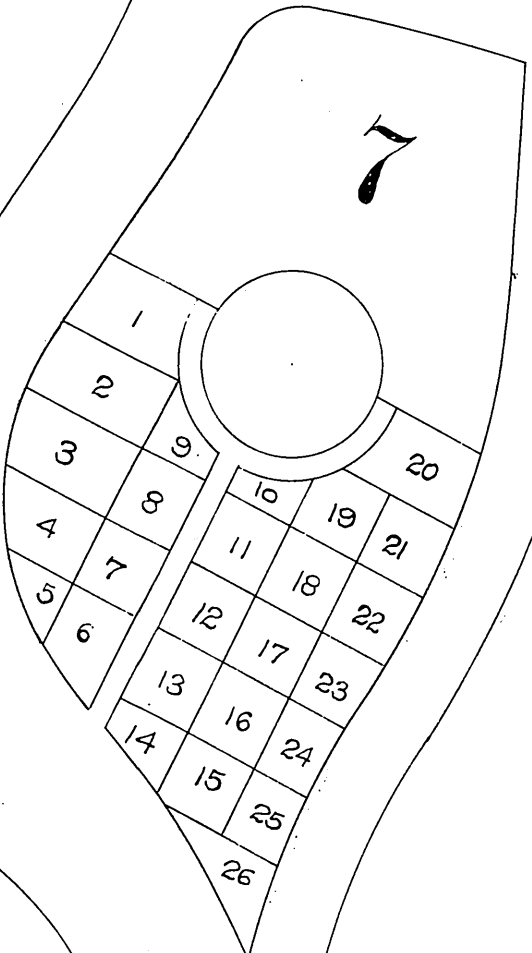


Map of a part of the

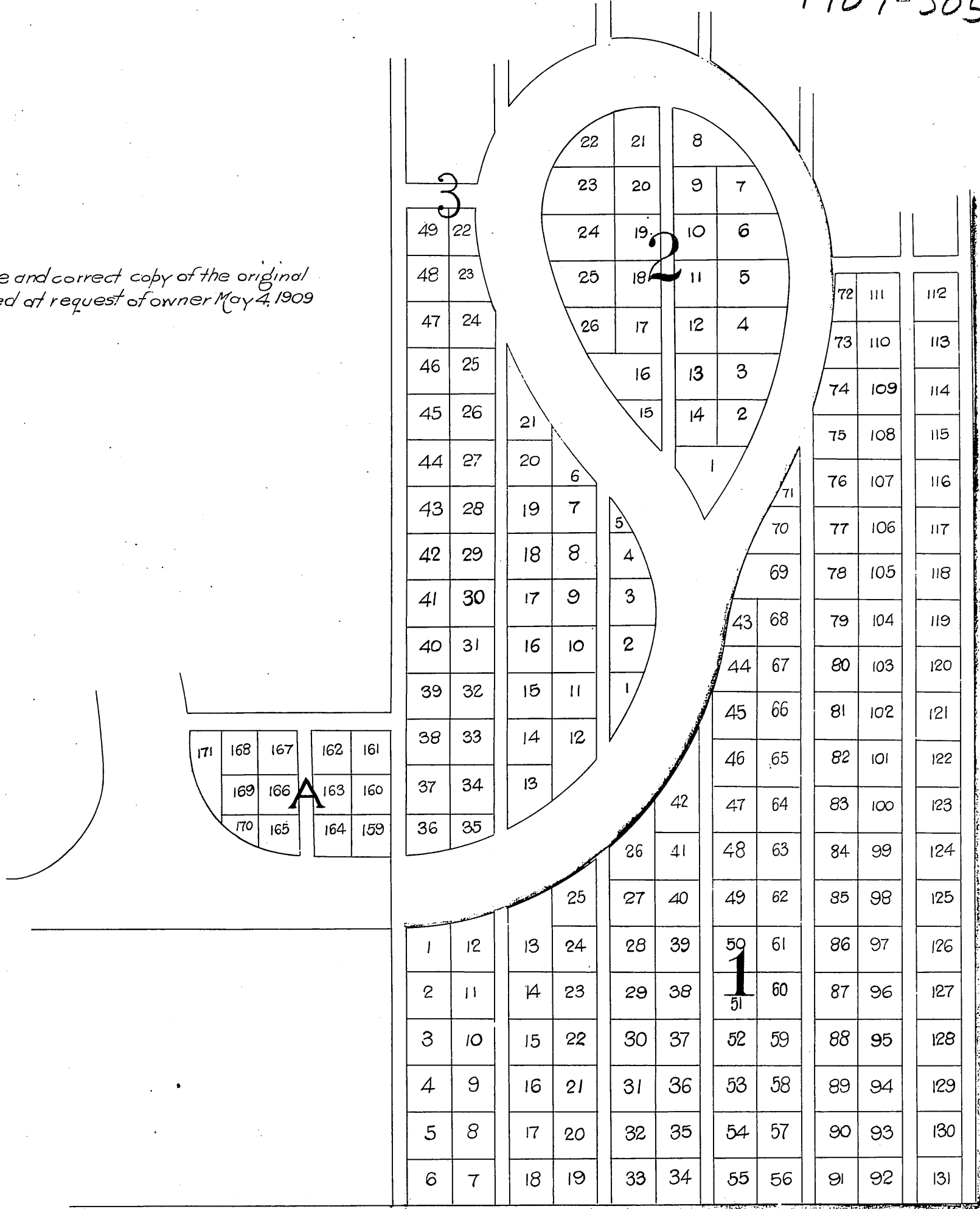

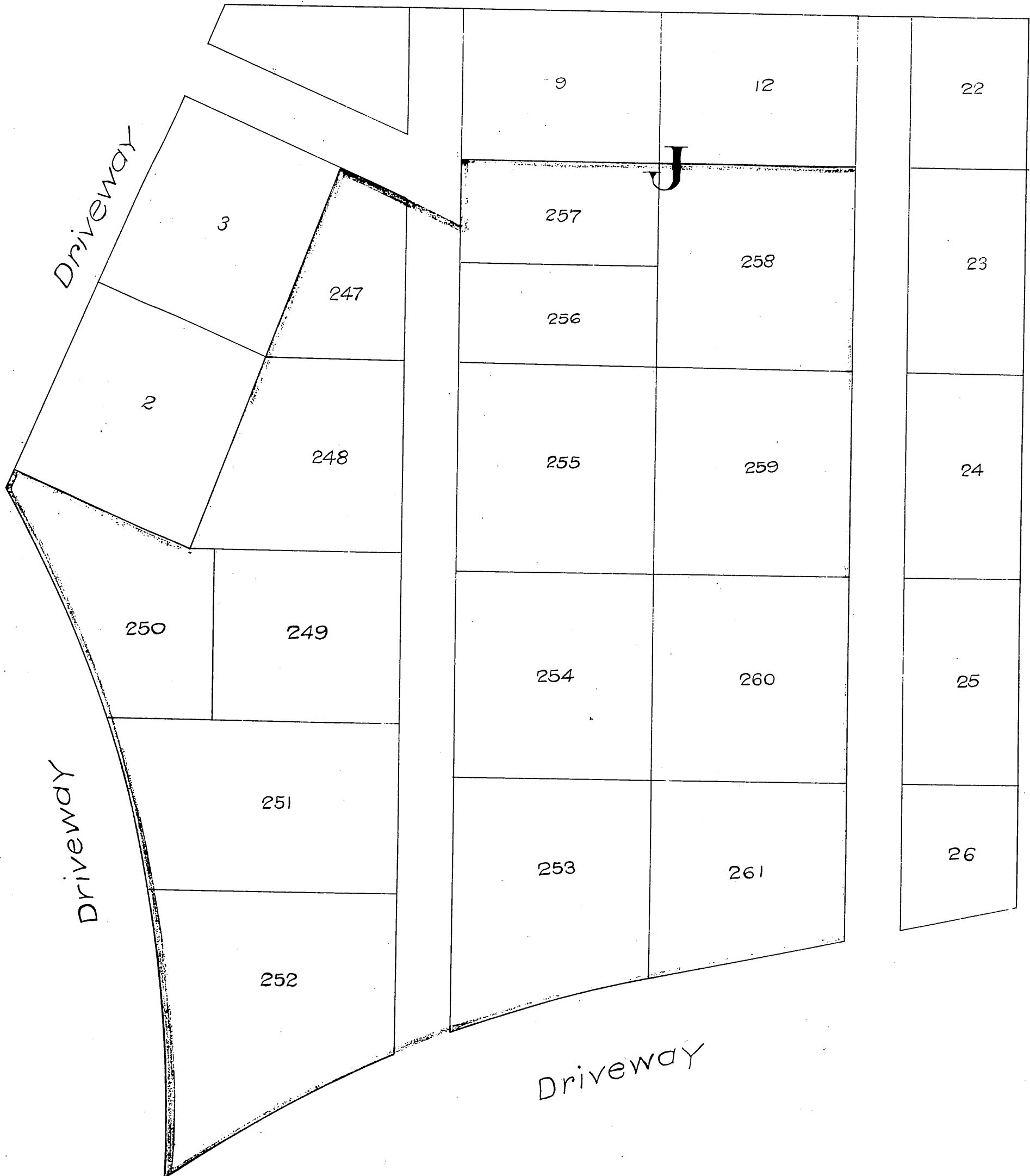

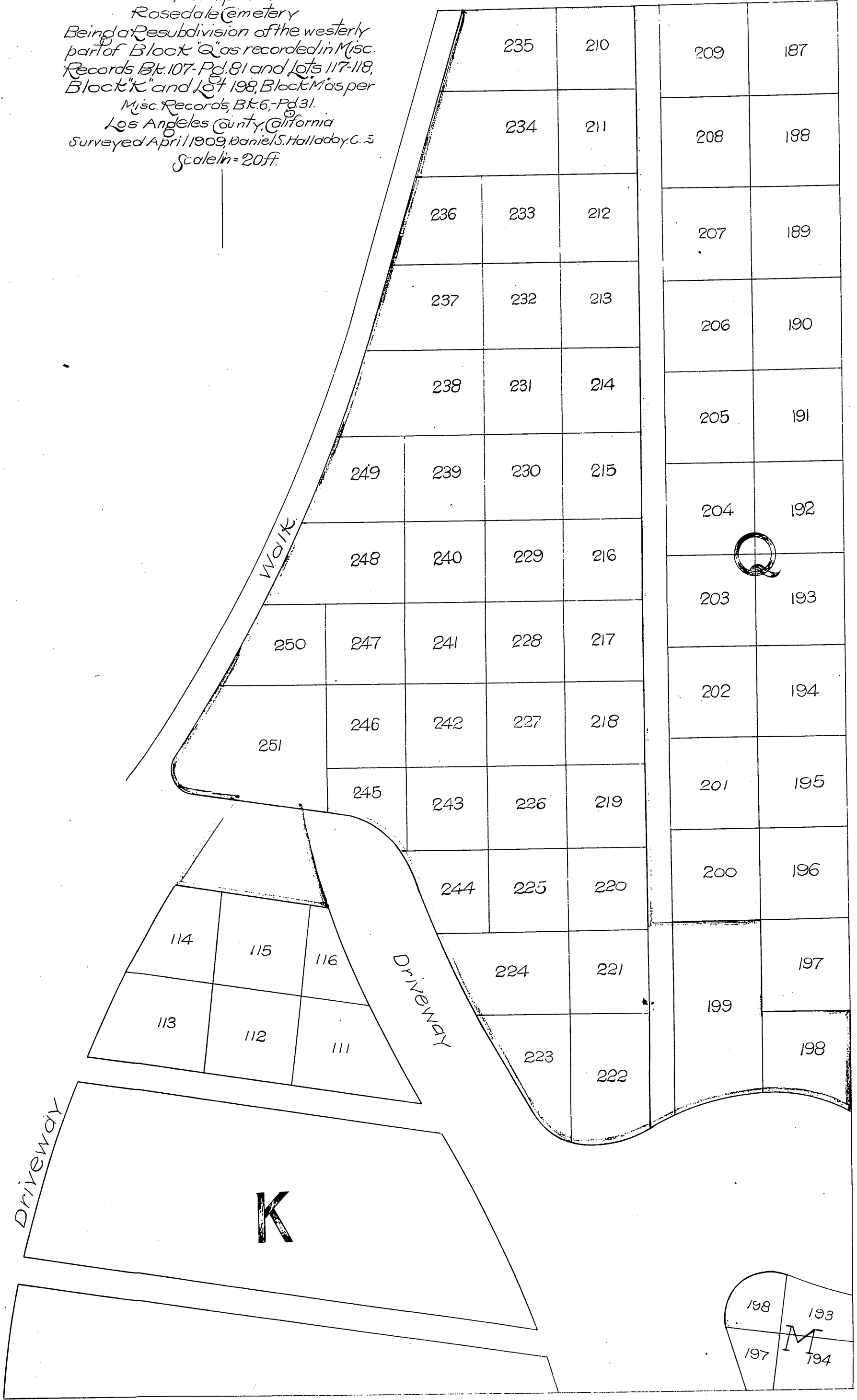
