Stakeholder Meeting Notes

Welcome and Introductions

• The Antelope Valley Integrated Regional Management (IRWM) Stakeholder Meeting was opened and led by Josh Uecker of Woodard & Curran (W&C).

Ongoing Regional Funding: Prop. 1 Round 2 IRWM Implementation Grant Projects

- The Department of Water Resources awarded the Antelope Valley IRWM Region approximately \$1 million under the Prop 1 Round 2 IRWM Implementation Grant Program. Award Agreement is now finalized. This is the last round of existing IRWM funding from the State (may have more to come in future bond measure).
- Josh Uecker (W&C) provided brief overview of upcoming funding and related information

 - o Potentially Upcoming Bond Measures
 - There are a couple of bond measures being discussed by the Legislature. Should have a better picture of what may be coming in Q1 of 2024.
 - Some measure is likely to make its way to the Nov 2024 ballot.
 - State budget shortfalls may mean less money available for grant funding for water projects in the coming year. W&C will continue to monitor for opportunities and present them to the AV IRWM group as they materialize.

Project Updates

 All projects funded under Prop 1 Round 1, the Urban Multibenefit Drought Relief Grant, and Prop 1 Round 2 are progressing. Three of the funded Prop 1 projects are at or near



- completion. Prop 1 Roud 2 projects are now under agreement with DWR and starting up. W&C will monitor future funding opportunities that support the IRWM program.
- Josh will follow up with Candice (City of Lancaster) with information on potentially upcoming bond measures and other water resources funding resources.
- Brent (Quartz Hill WD) will follow up with Vickie (AVRCD) about posting turf replacement program information on the WD website.

Topic Presentation – Storm Water Resource Plan

- Brenda Ponton of Woodard & Curran presented an overview of what a Storm Water Resource Plan (SWRP) is and what it is needed for (major driver is eligibility for state funding for future stormwater and dry weather flow capture projects).
